Is this correct?</p> <p>Response: M6.01 of Addendum #1 indicates that AH-1 is considered ADD ALTERNATE #1 and AH-3 is ADD ALTERNATE #2. AH-2 is considered Not In Contract as it was already installed as part of Phase #1. Drawings P2.01 & P2.01 have been modified to clarify the aforementioned. Refer to the bid form and summary of work specification section 011000.</p>
2	<p>Comment: On drawing P2.01 Detail 2 it's showing new plumbing in Family Toilet Room A118 and Janitors room A117 as part of the base bid but on drawing P2.02 Detail 6 & 7 riser diagram it's shaded indicating Not In Contract.</p> <p>Response: The scope indicated around the area of Family Toilet Room (A118) is limited to ADD ALTERNATE #1 (if awarded) and the connection of the condensate drain from AH-1.</p>
