- 4. In regards to the window treatment, is the hospital procuring this work or is Holt? Please advise. HOSPITAL
- 5. Please confirm the food equipment is to furnish & install by others. NIC YES BY OTHERS
- 6. Drawing A4.0a Floor note 17 New Lab Benches by Vendor. Is the hospital procuring this work? If not, we need specifications for lab benches / counter top etc. BENCHES BY HOSPITAL / PLEASE SEE ATTACHED FORMASPACE VENDOR DRAWINGS FOR REFERENCE.
- 7. Another thing is that the lab equipment suppliers usually include the sinks and trim packages. It states the GC to Provide sinks. Please advised. WE NEED TO CONFIRM THIS SCOPE IN REGARD TO DUCT, FAN AND CONNECTIONS / FROM RAYMOND VENDOR: THE KITCHEN CONTRACTOR WILL PROVIDE THE EXHAUST HOOD AND FIRE PROTECTION SYSTEM, HOWEVER, ANYTHING ABOVE THE HOOD, AS IN DUCTWORK, FANS, ETC. ARE TO BE BY MECHANICAL CONTRACTOR.
