


SEISMIC EQUIPMENT AND PIPE HANGER DESIGN
THE PLUMBING SYSTEM SHALL COMPLY WITH THE NEW YORK STATE UNIFORM FIRE PROTECTION AND BUILDING CODE SECTION 1613 AND APPLICABLE PROVISIONS OF ASCE 7 (ARCHITECTURAL, MECHANICAL AND ELECTRICAL COMPONENT SEISMIC DESIGN REQUIREMENTS).  PLUMBING CONTRACTOR SHALL HIRE NYS LICENSED PROFESSIONAL ENGINEER TO DESIGN AND PREPARE SHOP DRAWINGS WITH CALCULATIONS FOR EACH EQUIPMENT SUPPORT, PIPE SUPPORT, MULTIPLE PIPE SUPPORT, TRAPEZE AND SEISMIC RESTRAINT. SUBMIT SHOP DRAWINGS WITH CALCULATIONS TO ENGINEER FOR RECORD AND TO LOCAL AUTHORITY HAVING JURISDICTION FOR APPROVAL.
