NOTE:

 Bidders shall note that the two lowest bidders shall be prepared for immediate bid qualification review meetings as soon as Friday March 19, 2021 and shall be prepared with a DRAFT schedule of values, list of proposed subcontractors and list of any proposed material substitutions, if applicable. The low bidders will be contacted by Savin Engineers before the close of business on the day of the bid opening.

CLARIFICATIONS:

1. **Question: (Midland)** Please advise if fireproofing at existing steel beam as shown in section 2 on X2-101 is only in the corridor perimeter walls and on corridor side only, not within each individual rooms.

Response: Steel beam must have fireproofing on both sides.

Question: (Midland) Please advise if all new structural steel shown on S2-111 needs to be spray fireproofed

Response: New structural steel on sheet S2-111 is not required to be rated.

3. **Question: (Midland)** Please advise if demolition and reconstruction/relocation of new wall shown on DWG D2-120 & A2-101 on South wall in room 17 - Conference Room at the Main Office is part of Library Project 2 scope or Project 1?

Response: The demolition and reconstruction of the wall is project 1 scope.

4. **Question: (Midland)** Most of the existing walls in this space are noted to receive wall type 8 or 8A however there are several that don't have a designation. Please advise if all existing walls are to receive 8/8A or left with no wall type.

Response: Please provide area in question and correct sheet designation.

5. **Question: (Midland)** Under general notes, note 4 states to remove, modify and reset existing gas line. Is the plumbing contractor or GC responsible for this work? Also, is there a plan showing the scope extent and requirements?

Response: All work on gas lines at roof is by the Plumbing Contractor, who shall reference the plumbing drawings and specifications.

6. **Question: (Midland)** Please advise if the GC is responsible to supply a trailer for the CM in this contract?

Response: No, the only Owner/CM/Architect trailer is in the GC contract for Osborn, which is not being rebid.
