II. RE: THE DRAWINGS:

Item A: Drawing: 'P-001 Equipment Notes:

1. On P-001 under Equipment Notes they have four (4) above ground fuel tanks but there is only one (1) shown on the drawings. Please clarify?

There is only 1 fuel tank on this project: See: dwg. 'P-201':

'500 gallon above-ground gasoline storage tank & dispensing system'.

(The other 3 tanks are no longer included in this project.)

Item B: General Questions:

1. Is there a Plumbing underground drawing showing the new floor drain and standpipe layout with piping? Section calls out a drawing which is not included.

Piping is shown on dwg.'C-102'.

Addendum # 3 indicated: It is the responsibility of the Plumber to install the underground waste / sanitary piping to 5'-0" past the building foundation.

2. 'Is the temporary tent to be rented or purchased?'

It is at the Contractors discretion whether to rent or purchase the tent. The tent will remain in place for the duration that the golf carts will need to be stored outside. This duration includes: time to remove the existing Golf Cart Shed, construct & complete the New Golf Storage Facility to its full use.

3. 'Is there a heating plan for tent?'

There is no intention to provide heat in the tent.
