The scope of work includes but may not be limited to: Disconnect the boiler section in order to gain access to the defective section. Replace the defective section with one new one. Furnish and install new seals between the sections which were disassembled. Fill and test. Remove all debris. This boiler is one of two boilers; this work pertains to only to boiler #1.
