1	Comment:	Sheet SP.11 - Is all of the clearing and grubbing shown on sheet SP.11 under the GC contract?
	Response:	Yes, the GC is responsible for all clearing in accordance with the General Note #27 and technical specification Section 31 10 00 – Site Clearing.
2	Comment:	Sheet SP.21 - It was stated in the pre-bid meeting that the project was four contracts: GC, Electrical, Plumbing, and HVAC, and that all Contracts would be responsible for their own excavation, backfill, trash removal, etc. On Sheet SP.21 the Electrical Conduit in the northeast corner is stated to be done by the Electrical Contractor. However, the Sanitary line and Water Service in the southeast corner are not called out for a specific Contractor. It is assumed the Plumbing Contractor is responsible for this work including 5' outside of the building.
	Response:	The PC shall be responsible as outlined in Special Note #4 on page 011000-9 "Summary of Work".
3	Comment:	Sheet SP.12 - In the northeast corner of the building, a concrete pad for the propane tanks is called out. It is assumed that this concrete pad is the responsibility of the Plumbing Contractor.
	Response:	The GC shall be responsible for all concrete flat work in accordance with the applicable construction details and Division 32 technical specifications.

- 4 Comment: Sanitary piping outside the building on drawing #SP21. Who is responsible for furnish & install 4" sanitary piping out side the building (including connection to existing sewer manhole)? Who is responsible for the excavation/rock removal/backfill outside the building for the 4" sanitary?
 - Response: The PC shall be responsible as outlined in Special Note #4 on page 011000-9 "Summary of Work".
- 5 Comment: Domestic Water Piping Outside the Building. Who is responsible for furnish & install 1 ½" water piping outside the building (including connection to existing water service)? Who is responsible for the excavation/rock removal/backfill outside the building for the 1 ½" water?
 - Response: The PC shall be responsible as outlined in Special Note #4 on page 011000-9 "Summary of Work".
 - Comment: Who is responsible for excavation/rock removal/backfill for underground plumbing piping inside the building?
 - Response: The PC shall be responsible as outlined in Special Note #4 on page 011000-9 "Summary of Work".5
- 7 Comment: Mapes Canopies have stated that the canopy specified cannot be used for the type of application noted. They therefore said they cannot provide pricing. Please advise on another manufacturer.
 - Response: Canopies shall be as manufactured by the premanufactured building manufacturer. Canopies shall be sized to conform to the sizes indicated in the contract documents. Canopies shall match color of insulated metal panels.
