
1 CERAMIC TILE TO CERAMIC TRANSITION TS-1


2 WALK-OFF MAT TO CERAMIC TILE TRANSITION TS-2


3 LVT TO CERAMIC TILE TRANSITION TS-3


4 SINGLE HOLLYWOOD BEVEL TS-4


5 VCT TO LVT TRANSITION TS-5


7 INSIDE CORNER TILE TRANSITION DETAIL


8 INTEGRATED BASE DETAIL
