Subcontractor shall furnish and install a temporary 6'-0" tall chain link fence		
around the exposed site limits and connect to the existing, permanent site fence		
in order to fully enclose the project site.		
Subcontractor shall furnish and install 6000 linear feet of 6' post driven fence		
chain link fence panels. Subcontractor is not to perform this work until a utility		
locate is performed, by others and written approval to proceed has been		
provided by Whiting-Turner.		
Fencing installed by this subcontractor to include wind screen.		
Subcontractor to furnish and install 9 ea, 24'-0" wide swing gates.		
Unit rates for removal trips are included.		
Rental extensions will be based on the rates in Exhibit TBD and extended one		
month at a time or longer based on the projects needs at the end of this duration

Subcontractor shall furnish and install approximately 232 LF of timber fence (FN-07)		
per detail 3/L732 where shown on L214.		
Subcontractor shall furnish and install 1 pedestrian gate (FN-04) per detail 1/L732 where shown on L210.		
Subcontractor shall furnish and install 4 vehicular timber gates (FN-05) per detail		
1/L733 where shown on L210, L213 and L214.		
Subcontractor shall furnish and install 3 timber boom swing gates (FN-06) per detail		
2/L732 where shown on L213 and L215.
