

### Pre-Bid Addendum #2

### Response to RFI:

- 1. There is a detail for sidewalks shown on drawing G001, however, there are no sidewalks shown on the plans. Please advise.
  - Sidewalk is shown adjacent to the addition on Detail 1/A100; see revised drawing for additional dimensions.
- 2. There is no wheel cleaning truck entrance pad shown. Is it required. Please advise.
  - We are not familiar with the term 'wheel cleaning truck entrance pad'. A concrete apron is shown on Drawings S100 and S300.
- 3. There is no silt fence shown. Is it required? Please advise.
  - a. No.
- 4. Bid Form page #02 Par #1.7, calls to submit Performance Bond with the bid package. We spoke to our bonding company about this. Performance bond warranties the contract, and until contract is not awarded they do not issue Performance bond. This is industry standard. Please advise.
  - a. Remove requirement for Performance Bond as part of Bid Package.
- 5. Is the new proposed storage room #111 going to be built on the raise existing slab or are we removing the slab and bring the elevation of the floor lower? The reason we are asking for clarification is that detail # 4 on Plan A-100 shows the new door # 111.1 on the Bay slab level. Please advise.
  - a. Details 3/A100 and 4/A100 are clearly marked 'Alternate'. Base Bid includes the construction of Storage 111 at existing slab elevation; Alternate includes removal of slab and construction of Storage 111 at bay elevation.
- 6. As you are aware of the volatility of the Market. Suppliers are not warranting to hold their prices due to unpredictable inflation rise going on and shortage of material. Our supplier just informed us that the lead time on Sectional doors are like 20 weeks from the time we release the order. The project duration itself is not more than 5 months. We suggestion the agency should look into this matter and set an monetary and time allowance in the bid? Please advise.
  - Contractors Bid shall include cost of construction at time of Bid. Project Schedule shall be as specified. General Conditions and Owner-Contractor Agreement include provisions for increase in cost or delays in schedule.
- 7. Please precise Roof drain Spec (size, make & model number) for Storm/Overflow drain piping.
  - a. Provide roof drain per tag RD-1/G001; specified drain for required 4" line is 14".
- 8. Plan A-301, Section # 01 calls for Electrical Hoist & Trolley. Is this part of our Bid? Please advise.
  - a. Trolley/hoist to be furnished by Owner and installed by Contractor.


