PLASTIC TOILET COMPARTMENTS

PART 1 - GENERAL

1.1 RELATED DOCUMENTS

- A. Drawings and general provisions of the Contract, including General and Supplementary Conditions and Division 01 Specification Sections, apply to this Section.

1.2 SUMMARY

- A. Section Includes:
 - 1. Solid-plastic toilet compartments configured as toilet enclosures entrance screens, and urinal screens.
- B. Related Requirements:
 - 1. Section 061000 "Rough Carpentry" for blocking.
 - 2. Section 102800 "Toilet, Bath, and Laundry Accessories" for accessories mounted on toilet compartments.

1.3 COORDINATION

- A. Coordinate requirements for blocking, reinforcing, and other supports concealed within wall.

1.4 ACTION SUBMITTALS

- A. Product Data:
 - 1. Solid-plastic toilet compartments:
 - a. Include construction details, material descriptions, dimensions of individual components and profiles, and finishes for toilet compartments.
- B. Shop Drawings: For solid-plastic toilet compartments.
 - 1. Include plans, elevations, sections, details, and attachment details.
 - 2. Show locations of cutouts for compartment-mounted toilet accessories.
 - 3. Show locations of centerlines of toilet fixtures.
 - 4. Show locations of floor drains.
- C. Samples for Initial Selection: Manufacturer's standard color sheets, showing full range of available colors for each type of toilet compartment material indicated.
 - 1. Include Samples of hardware and accessories involving material and color selection.

- D. Samples for Verification: Actual sample of finished products for each type of toilet compartment indicated.
1. Size: 6-inch-square, of same thickness indicated for Work.
 2. Include each type of hardware and accessory.

1.5 INFORMATIONAL SUBMITTALS

- A. Certificates:
1. Product Certificates: For each type of toilet compartment by manufacturer.

1.6 CLOSEOUT SUBMITTALS

- A. Maintenance Data: For toilet compartments.

1.7 MAINTENANCE MATERIAL SUBMITTALS

- A. Extra Stock Material: Furnish extra materials that match products installed and that are packaged with protective covering for storage and identified with labels describing contents.
1. Door Hinges: One hinge(s) with associated fasteners.
 2. Latch and Keeper: One latch(es) and keeper(s) with associated fasteners.
 3. Door Bumper: One bumper(s) with associated fasteners.
 4. Door Pull: One door pull(s) with associated fasteners.
 5. Fasteners: 10 fasteners of each size and type.

1.8 FIELD CONDITIONS

- A. Field Measurements: Verify actual locations of toilet fixtures, walls, columns, ceilings, and other construction contiguous with toilet compartments by field measurements, and coordinate before fabrication.

PART 2 - PRODUCTS

2.1 LEED PERFORMANCE REQUIREMENTS

- A. For interior, wet-applied, field installed adhesives, sealants, paints, and coatings, provide products that meet both Volatile Organic Compound (VOC) content limits and emissions testing requirements (General Emissions Evaluation), as outlined in Section 018113.14 - SUSTAINABLE DESIGN REQUIREMENTS.
- B. Provide interior products that meet emissions testing requirements (General Emissions Evaluation), as outlined in Section 018113.14 - "SUSTAINABLE DESIGN REQUIREMENTS".
- C. Provide products that meet Composite Wood Evaluation requirements, as outlined in Section 018113.14 - "SUSTAINABLE DESIGN REQUIREMENTS".

- D. Provide products with third party certified Type III industry-wide (generic) or product-specific Environmental Product Declarations (EPDs).
- E. Provide products with Manufacturer's product specific Health Product Declarations (HPDs) with full disclosure of known health hazards.

2.2 PERFORMANCE REQUIREMENTS

- A. Fire Performance: Tested in accordance with, and pass the acceptance criteria of, NFPA 286.
- B. Regulatory Requirements: Comply with applicable provisions in the U.S. Department of Justice "2010 ADA Standards for Accessible Design" and ICC A117.1 for toilet compartments designated as accessible.

2.3 SOLID-PLASTIC TOILET COMPARTMENTS

- A. Manufacturers: Subject to compliance with requirements, provide products **Scranton Products** – **Hiney Hiders**, or equivalent products by one of the following:
 - 1. Accurate Partitions Corp., an ASI Group Company.
 - 2. General Partitions Mfg. Corp.
- B. Toilet-Enclosure Style: Overhead braced.
- C. Entrance-Screen Style: Overhead braced.
- D. Urinal-Screen: Manufacturer's standard floor supported, wall mounted one piece HDPE panel with shoe and sleeve (cap) matching that on the urinal screen panel.
- E. Door, Panel, Screen, and Pilaster Construction: Solid, high-density polyethylene (HDPE) panel material, not less than 1 inch thick, seamless, with eased edges, and with homogenous color and pattern throughout thickness of material.
 - 1. Color and Pattern: As selected by Architect from manufactures standard colors, orange peel texture.
- F. Pilaster Shoes and Sleeves (Caps): Pilaster Shoes: 3 inches (76 mm) high one-piece molded HDPE. Secured to pilasters with a stainless steel tamper resistant Torx head sex bolt.
 - 1. Color: As selected by Architect from manufactures standard colors.
- G. PVC Brackets (Fittings): Full height (continuous). Extruded PVC plastic.
- I. Overhead Bracing: Manufacturer's standard continuous, extruded-aluminum head rail with antigrip profile and in manufacturer's standard finish.

2.4 **HARDWARE AND ACCESSORIES**

- A. Hardware and Accessories, Heavy Duty: Manufacturer's heavy-duty operating hardware and accessories.
1. Hinges: Manufacturer's minimum 0.062-inch-thick stainless steel paired, self-closing type that can be adjusted to hold doors open at any angle up to 90 degrees, allowing emergency access by lifting door. Mount with through bolts.
 2. Latch and Keeper: Manufacturer's heavy-duty, surface-mounted, cast-stainless steel latch unit, designed to resist damage due to slamming, with combination rubber-faced door strike and keeper, and with provision for emergency access. Provide units that comply with regulatory requirements for accessibility at compartments designated as accessible. Mount with through bolts.
 3. Coat Hook: Manufacturer's heavy-duty combination cast-stainless steel hook and rubber-tipped bumper, sized to prevent inswinging door from hitting compartment-mounted accessories. Mount with through bolts.
 - a. Provide coat hook without bumper on Handicap stalls.
 4. Door Bumper: Manufacturer's heavy-duty, rubber-tipped, cast-stainless steel bumper at outswinging doors and entrance-screen doors. Mount with through bolts.
 - a. At doors swinging more than 90 degrees, provide 3 pilaster mounted doorstops.
 5. Door Pull: Manufacturer's heavy-duty, cast-stainless steel pull at outswinging doors that complies with regulatory requirements for accessibility. Provide units on both sides of doors at compartments designated as accessible. Mount with through bolts.
 - a. Where accessible water closet compartments or single occupancy toilet rooms are provided, the compartment or room doors shall have a pull handle mounted 6 inches from the hinge side on the compartment or room side of the door. This handle shall be between 26 inches and 36 inches from the floor and shall meet the requirements of Section 404.2.6 of ICC/ANSI A117.1.
- B. Anchorages and Fasteners: Manufacturer's standard exposed fasteners of stainless steel, finished to match the items they are securing, with theft-resistant-type heads. Provide sex-type bolts for through-bolt applications. For concealed anchors, use stainless steel, hot-dip galvanized steel, or other rust-resistant, protective-coated steel compatible with related materials.

2.5 **MATERIALS**

- A. Stainless Steel Sheet: ASTM A240/A240M or ASTM A666, Type 304, stretcher-leveled standard of flatness.

2.6 FABRICATION

- A. Fabrication, General: Fabricate toilet compartment components to sizes indicated. Coordinate requirements and provide cutouts for through-partition toilet accessories where required for attachment of toilet accessories.
- B. Overhead-Braced Units: Provide manufacturer's standard corrosion-resistant supports, leveling mechanism, and anchors at pilasters to suit floor conditions. Provide shoes at pilasters to conceal supports and leveling mechanism.
- C. Door Size and Swings: Unless otherwise indicated, provide 24-inch-wide, inswinging doors for standard toilet compartments and 36-inch-wide, outswinging doors with a minimum 32-inch-wide, clear opening for compartments designated as accessible.
- D. Urinal-Screen Panels: Provide manufacturer's standard corrosion-resistant anchoring assemblies with leveling adjustment at bottoms of panels. Provide shoes and sleeves (caps) at panels to conceal anchorage.

PART 3 - EXECUTION

3.1 EXAMINATION

- A. Examine areas and conditions, with Installer present, for compliance with requirements for fastening, support, alignment, operating clearances, and other conditions affecting performance of the Work.
 - 1. Confirm location and adequacy of blocking and supports required for installation.
- B. Proceed with installation only after unsatisfactory conditions have been corrected.

3.2 INSTALLATION OF PLASTIC TOILET COMPARTMENTS

- A. General: Comply with manufacturer's written installation instructions. Install units rigid, straight, level, and plumb. Secure units in position with manufacturer's recommended anchoring devices.
 - 1. Maximum Clearances:
 - a. Pilasters and Panels: 1/2 inch.
 - b. Panels and Walls: 1 inch.
 - 2. Stirrup Brackets: Secure panels to walls and to pilasters with no fewer than two brackets attached near top and bottom of panel.
 - a. Locate wall brackets, so holes for wall anchors occur in masonry or tile joints.
 - b. Align brackets at pilasters with brackets at walls.

- B. Overhead-Braced Units: Secure pilasters to floor and level, plumb, and tighten. Set pilasters with anchors penetrating not less than 1-3/4 inches into structural floor unless otherwise indicated in manufacturer's written instructions. Secure continuous head rail to each pilaster with no fewer than two fasteners. Hang doors to align tops of doors with tops of panels and adjust, so tops of doors are parallel with overhead brace when doors are in closed position.
- C. Urinal Screens: Attach with anchoring devices to suit supporting structure. Set units level and plumb, rigid, and secured to resist lateral impact.

3.3 ADJUSTING

- A. Hardware Adjustment: Adjust and lubricate hardware according to hardware manufacturer's written instructions for proper operation. Set hinges on inswinging doors to hold doors open approximately 30 degrees from closed position when unlatched. Set hinges on outswinging doors and doors in entrance screens to return doors to fully closed position.

WIRE MESH PARTITIONS

PART 1 - GENERAL

1.1 SUMMARY

- A. Section Includes:
 - 1. Standard-duty wire mesh partitions.

1.2 DEFINITIONS

- A. Lock Crimp: Deep crimps at points of the intersection that lock wires securely in place.

1.3 ACTION SUBMITTALS

- A. Product Data:
 - 1. Wire mesh partitions.
- B. Shop Drawings:
 - 1. Include plans, elevations, sections, and attachment details.
 - 2. Indicate clearances required for operation of doors.
- C. Samples for Verification: Panel constructed of specified frame members and wire mesh. Show method of finishing members at intersections.
 - 1. Size: 12 by 12 inches (300 by 300 mm).
- D. Delegated Design Submittals: For wire mesh partitions indicated to comply with performance requirements and design criteria, including analysis data signed and sealed by the qualified professional engineer responsible for their preparation.

1.4 INFORMATIONAL SUBMITTALS

- A. Certificates:
 - 1. Welding certificates.
- B. Qualification Statements: For Installer.
- C. Delegated design engineer qualifications.

1.5 CLOSEOUT SUBMITTALS

- A. Operation and Maintenance Data: For wire mesh partition hardware.

1.6 QUALITY ASSURANCE

- A. Qualifications:
1. Installers: Entity that employs installers and supervisors who are trained and approved by manufacturer.
 2. Welding Qualifications: Qualify procedures and personnel in accordance with the following welding codes:
 - a. AWS D1.1/D1.1M.
 - b. AWS D1.3/D1.3M.

1.7 DELIVERY, STORAGE, AND HANDLING

- A. Deliver wire mesh items with cardboard protectors on perimeters of panels and doors and with posts wrapped to provide protection during transit and Project-site storage. Use vented plastic.
- B. Inventory wire mesh partition door hardware on receipt, and provide secure lockup for wire mesh partition door hardware delivered to Project site.
1. Tag each item or package separately with identification, and include basic installation instructions with each item or package.
- C. Deliver keys to Owner by registered mail or overnight package service.

1.8 FIELD CONDITIONS

- A. Field Measurements: Verify actual dimensions of construction contiguous with wire mesh units by field measurements before fabrication.

2.2 SOURCE LIMITATIONS

- A. For wire mesh products, obtain each color, grade, finish, type, and variety from single source with resources to provide products of consistent quality in appearance and physical properties.

2.3 PERFORMANCE REQUIREMENTS

- A. Delegated Design: Engage a qualified professional engineer, as defined in Section 014000 "Quality Requirements," to design wire mesh units.
- B. Structural Performance: Wire mesh units to withstand the effects of gravity loads and the following loads and stresses within limits and under conditions indicated.
 1. Concentrated load of 50 lbf (0.22 kN) applied horizontally on an area of 1 sq. ft. (0.093 sq. m) at any location on a panel.
 2. Total load of 200 lbf (0.89 kN) applied uniformly over each panel.
 3. Concentrated load and total load need not be assumed to act concurrently.
- C. Seismic Performance: Wire mesh units to withstand the effects of earthquake motions determined in accordance with ASCE/SEI 7.
- D. Regulatory Requirements: Comply with applicable provisions in 2010 ADA Standards for Accessible Design and ICC A117.1 for doors and gates designated as accessible.

2.4 STANDARD-DUTY WIRE MESH PARTITIONS

- A. Mesh: 0.135-inch- (3.5-mm-) diameter, intermediate-crimp steel wire woven into 1-1/2-inch (38-mm) diamond mesh.
- B. Vertical Panel Framing: 1-1/4-by-5/8-by-0.080-inch (32-by-16-by-2.0-mm) cold-rolled, C-shaped steel channels with holes for 1/4-inch- (6-mm-) diameter bolts not more than 12 inches (300 mm) o.c.
- C. Horizontal Panel Framing: 1-by-1/2-by-1/8-inch (25-by-13-by-3.2-mm) cold-rolled steel channels.

- D. Horizontal Panel Stiffeners: Two cold-rolled steel channels, 3/4 by 3/8 by 1/8 inch (19 by 9.5 by 3.2 mm), bolted or riveted toe to toe through mesh; or one 1-by-1/2-by-1/8-inch (25-by-13-by-3.2-mm) cold-rolled steel channel with wire mesh woven through channel.
 - E. Top Capping Bars: 2-1/4-by-1-inch (57-by-25-mm) cold-rolled steel channels.
 - F. Posts for 90-Degree Corners: 1-1/4-by-1-1/4-by-1/8-inch (32-by-32-by-3.2-mm) steel angles or square tubes with holes for 1/4-inch- (6-mm-) diameter bolts aligning with bolt holes in vertical framing; with floor anchor clips.
 - G. Posts for Other-Than-90-Degree Corners: Steel pipe or tubing with holes for 1/4-inch- (6-mm-) diameter bolts aligning with bolt holes in vertical framing; with floor anchor clips.
 - 1. Partitions up to 12 Ft. (3.7 m) High: 1-1/4-inch (32-mm) OD by 1/8 inch (3.2 mm).
 - H. Line Posts: 3-inch-by-4.1-lb (76-mm-by-1.9-kg) or 3-1/2-by-1-1/4-by-0.127-inch (89-by-32-by-3.2-mm) steel channels; with 1/4-inch (6.4-mm) steel base plates.
 - I. Three-Way Intersection Posts: 1-1/4-by-1-1/4-by-1/8-inch (32-by-32-by-3.2-mm) steel tubes or channels, with holes for 1/4-inch- (6-mm-) diameter bolts aligned for bolting to adjacent panels.
 - J. Four-Way Intersection Posts: 1-1/4-by-1-1/4-by-1/8-inch (32-by-32-by-3.2-mm) steel tubes, with holes for 1/4-inch- (6-mm-) diameter bolts aligned for bolting to adjacent panels.
 - K. Floor Shoes: Metal, not less than 2 inches (50 mm) high; sized to suit vertical framing, drilled for attachment to floor, and with setscrews for leveling adjustment.
 - L. Swinging Doors: Fabricated from same mesh as partitions, with framing fabricated from 1-1/4-by-1/2-by-1/8-inch (32-by-13-by-3.2-mm) steel channels or 1-1/4-by-5/8-by-0.080-inch (32-by-16-by-2.0-mm) cold-rolled, C-shaped steel channels, banded with 1-1/4-by-1/8-inch (32-by-3.2-mm) flat steel bar cover plates on four sides, and with 1/8-inch- (3.2-mm-) thick angle strike bar and cover on strike jamb.
 - 1. Hinges: Full-surface type, 3-by-3-inch (76-by-76-mm) steel, three per door; bolted, riveted, or welded to door and jamb framing.
 - 2. Cylinder Lock: Mortise type with manufacturer's standard cylinder; operated by key outside and lever inside.
 - a. Front Trim: WireCrafters "SF-4" Cylinder less Interchange Core or equivalent approved by Architect.
 - b. Rear Trim: WireCrafters "SB-4" Lever Handle or equivalent approved by Architect.
- Inactive Leaf Hardware: Cane bolt at bottom and chain bolt at top.
- M. Accessories:
 - 1. Sheet Metal Base: 0.035-inch- (0.9-mm-) thick, steel sheet.
 - 2. Adjustable Filler Panels: 0.060-inch- (1.5-mm-) thick, steel sheet; capable of filling openings from 2 to 12 inches (50 to 300 mm).

3. Wall Clips: Manufacturer's standard, steel sheet; allowing up to 1 inch (25 mm) of adjustment.

N. Finish: Powder-coated finish unless otherwise indicated.

1. Color: As selected by Architect from manufacturer's full range.

2.5 MATERIALS

- A. Steel Wire: ASTM A510/A510M.
- B. Steel Plates, Channels, Angles, and Bars: ASTM A36/A36M.
- C. Steel Sheet: Cold-rolled steel sheet, ASTM A1008/A1008M, Commercial Steel (CS), Type B.
- D. Steel Tubing: ASTM A500/A500M, cold-formed structural-steel tubing or ASTM A513/A513M, Type 5, mandrel-drawn mechanical tubing.
- E. Panel-to-Panel Fasteners: Manufacturer's standard steel bolts, nuts, and washers.
- F. Post-Installed Anchors: Capable of sustaining, without failure, a load equal to 6 times the load imposed when installed in unit masonry and 4 times the load imposed when installed in concrete, as determined by testing in accordance with ASTM E488/E488M, conducted by a qualified independent testing agency.
 1. Material for Interior Locations: Carbon-steel components are zinc plated to comply with ASTM B633 or ASTM F1941/F1941M, Class Fe/Zn 5, unless otherwise indicated.
- G. Power-Driven Fasteners: ICC-ES AC70.
- H. Seismic Bracing: Angles with legs not less than 1-1/4 inches (32 mm) wide, formed from 0.040-inch- (1.0-mm-) thick, metallic-coated steel sheet; with bolted connections and 1/4-inch- (6-mm-) diameter bolts.

2.6 FABRICATION

- A. General: Fabricate wire mesh items from components of sizes not less than those indicated. Use larger-sized components as recommended by wire mesh item manufacturer. Furnish bolts, hardware, and accessories required for complete installation with manufacturer's standard finishes.
 1. Fabricate wire mesh items to be readily disassembled.
 2. Welding: Weld corner joints of framing and grind smooth, leaving no evidence of joint.

- B. Standard-Duty Wire Mesh Partitions: Fabricate wire mesh partitions with cutouts for pipes, ducts, beams, and other items indicated. Finish edges of cutouts to provide a neat, protective edge.
1. Mesh: Securely clinch mesh to framing.
 2. Framing: Fabricate framing with mortise-and-tenon corner construction.
 - a. Provide horizontal stiffeners as indicated or, if not indicated, as required by panel height and as recommended by wire mesh partition manufacturer. Weld horizontal stiffeners to vertical framing.
 - b. Fabricate three- and four-way intersections using manufacturer's standard connecting clips and fasteners.
 - c. Fabricate partition and door framing with slotted holes for connecting adjacent panels.
 3. Fabricate wire mesh partitions with 3 to 4 inches (75 to 100 mm) of clear space between finished floor and bottom horizontal framing.
 4. Doors: Align bottom of door with bottom of adjacent panels.
 - a. For doors that do not extend full height of partition, provide transom over door, fabricated from same mesh and framing as partition panels.
 5. Hardware Preparation: Mortise, reinforce, drill, and tap doors and framing as required to install hardware.

2.7 STEEL AND IRON FINISHES

- A. Preparation for Shop Priming: Prepare surfaces to comply with SSPC-SP 3, "Power Tool Cleaning."
- B. Shop Priming: Apply shop primer to uncoated surfaces of wire mesh units unless otherwise indicated. Comply with SSPC-PA 1, "Paint Application Specification No. 1: Shop, Field, and Maintenance Painting of Steel," for shop painting.
- C. Powder-Coat Finish: Immediately after cleaning and pretreating, apply manufacturer's standard baked-on powder-coat finish, suitable for use indicated, with a minimum dry film thickness of 2 mils (0.05 mm).
1. Color and Gloss: As selected by Architect from manufacturer's full range.

PART 3 - EXECUTION

3.1 EXAMINATION

- A. Examine areas, with Installer present, for compliance with requirements for installation tolerances and other conditions affecting performance of the Work.

- B. Examine floors for suitable conditions where wire mesh items will be installed.
- C. Examine walls to which wire mesh items will be attached for properly located blocking, grounds, and other solid backing for attachment of support fasteners.
- D. Proceed with installation only after unsatisfactory conditions have been corrected.

3.2 INSTALLATION OF WIRE MESH PARTITIONS

- A. Anchor wire mesh partitions to floor with 3/8-inch- (9.5-mm-) diameter, postinstalled expansion anchors at 12 inches (305 mm) o.c. through floor shoes located at each post and corner. Adjust wire mesh partition posts in floor shoes to achieve level and plumb installation.
 - 1. Anchors may be set with power-actuated fasteners instead of postinstalled expansion anchors if indicated on Shop Drawings.
- B. Anchor wire mesh partitions to walls at 12 inches (305 mm) o.c. through back corner panel framing and as follows:
 - 1. For concrete and solid masonry anchorage, use expansion anchors.
 - 2. For steel-framed gypsum board assemblies, use lag bolts set into wood backing between studs. Coordinate with stud installation to locate backing members.
- C. Secure top capping bars to top framing channels with 1/4-inch- (6-mm-) diameter, "U" bolts spaced not more than 28 inches (700 mm) o.c.
- D. Provide line posts at locations indicated or, if not indicated, as follows:
 - 1. For partitions that are 7 to 9 ft. (2.1 to 2.7 m) high, spaced at 15 to 20 ft. (4.6 to 6.1 m) o.c.
 - 2. For partitions that are 10 to 12 ft. (3.0 to 3.7 m) high, located between every other panel.
 - 3. For partitions that are more than 12 ft. (3.7 m) high, located between each panel.
- E. Provide seismic supports and bracing as indicated or, if not indicated, as recommended by manufacturer and as required for stability, extending and fastening members to supporting structure.
- F. Where standard-width wire mesh partition panels do not fill entire length of run, provide adjustable filler panels to fill openings.
- G. Install doors complete with door hardware.
- H. Weld or bolt sheet metal bases to wire mesh partitions and doors.
- I. Bolt accessories to wire mesh partition framing.

3.3 REPAIR

A. Repair Painting:

- A. Warranty: Sample of special warranty.

1.6 CLOSEOUT SUBMITTALS

- A. Operation and Maintenance Data: For fire extinguishers to include in maintenance manuals.

1.7 COORDINATION

- A. Coordinate type and capacity of fire extinguishers with fire-protection cabinets to ensure fit and function.

1.8 WARRANTY

- A. Special Warranty: Manufacturer's standard form in which manufacturer agrees to repair or replace fire extinguishers that fail in materials or workmanship within specified warranty period.
 - 1. Failures include, but are not limited to, the following:
 - a. Failure of hydrostatic test according to NFPA 10 when testing interval required by NFPA 10 is within the warranty period.
 - b. Faulty operation of valves or release levers.
 - 2. Warranty Period: Six years from date of Substantial Completion.

 - 5. Instruction Labels: Include pictorial marking system complying with NFPA 10, Appendix B, and bar coding for documenting fire-extinguisher location, inspections, maintenance, and recharging.

PART 1 - GENERAL

1.1 RELATED DOCUMENTS

- A. Drawings and general provisions of the Contract, including General and Supplementary Conditions and Division 01 Specification Sections, apply to this Section.

1.2 SUMMARY

- A. Section Includes:
 - 1. Knocked-down corridor lockers.

1.3 PREINSTALLATION MEETINGS

- A. Preinstallation Conference: Conduct conference at Project site.

1.4 ACTION SUBMITTALS

- A. Product Data: For each type of product.
 - 1. Include construction details, material descriptions, dimensions of individual components and profiles, and finishes for each type of metal locker and bench.
- B. Shop Drawings: For metal lockers.
 - 1. Include plans, elevations, sections, and attachment details.
 - 2. Show locker trim and accessories.
 - 3. Include locker identification system and numbering sequence.
- C. Samples: For each color specified, in manufacturer's standard size.
- D. Samples for Initial Selection: Manufacturer's color charts showing the full range of colors available.
- E. Samples for Verification: For the following products, in manufacturer's standard size:
 - 1. Lockers and equipment.
 - 2. Locker benches.
- F. Product Schedule: For lockers. Use same designations indicated on Drawings.

1.5 INFORMATIONAL SUBMITTALS

- A. Qualification Data: For Installer.
- B. Sample Warranty: For special warranty.

1.6 CLOSEOUT SUBMITTALS

- A. Maintenance Data: For adjusting, repairing, and replacing locker doors and latching mechanisms to include in maintenance manuals.

1.7 MAINTENANCE MATERIAL SUBMITTALS

- A. Furnish extra materials that match products installed and that are packaged with protective covering for storage and identified with labels describing contents.
 - 1. The following metal locker hardware items equal to 10 percent of amount installed for each type and finish installed, but no fewer than five units:
 - a. Locks.
 - b. Blank identification plates.
 - c. Hooks.

1.8 DELIVERY, STORAGE, AND HANDLING

- A. Do not deliver metal lockers until spaces to receive them are clean, dry, and ready for their installation.

1.9 FIELD CONDITIONS

- A. Field Measurements: Verify actual dimensions of recessed openings by field measurements before fabrication.

1.10 COORDINATION

- A. Coordinate sizes and locations of concrete and wood bases for metal lockers.
- B. Coordinate sizes and locations of framing, blocking, furring, reinforcements, and other related units of work specified in other Sections to ensure that metal lockers can be supported and installed as indicated.

1.11 WARRANTY

- A. Special Warranty: Manufacturer agrees to repair or replace components of metal lockers that fail in materials or workmanship, excluding finish, within specified warranty period.
 - 1. Failures include, but are not limited to, the following:
 - a. Structural failures.
 - b. Faulty operation of latches and other door hardware.
 - 2. Damage from deliberate destruction and vandalism is excluded.
 - 3. Warranty Period for Knocked-Down Metal Lockers: One year from date of Substantial Completion.
 - 4. Warranty Period for Welded Metal Lockers: One year from date of Substantial Completion.

PART 2 - PRODUCTS

2.1 MANUFACTURERS

- A. Source Limitations: Obtain metal lockers, locker benches and accessories from single source from single locker manufacturer.

2.2 PERFORMANCE REQUIREMENTS

- C. Doors: One piece; fabricated from 16 gauge or 18 gauge nominal-thickness steel sheet; formed into channel shape with double bend at vertical edges and with right-angle single bend at horizontal edges.

1. Doors less than 12 inches wide may be fabricated from 0.048-inch nominal-thickness steel sheet.
 2. Doors for box lockers less than 15 inches wide may be fabricated from 0.048-inch nominal-thickness steel sheet.
 3. Reinforcement: Manufacturer's standard reinforcing angles, channels, or stiffeners for doors more than 15 inches wide; welded to inner face of doors.
 4. Stiffeners: Manufacturer's standard full-height stiffener fabricated from 0.048-inch nominal-thickness steel sheet; welded to inner face of doors.

1. Latch Hooks: Equip doors 48 inches and higher with three latch hooks and doors less than 48 inches high with two latch hooks; fabricated from 0.105-inch nominal-thickness steel sheet; welded or riveted to full-height door strikes; with resilient silencer on each latch hook.

- R. Finish: Baked enamel or powder coat.

2.4 LOCKS

- A. Combination Padlock: Provided by Owner.

2.5 FABRICATION

- A. Fabricate metal lockers square, rigid, without warp, and with metal faces flat and free of dents or distortion. Make exposed metal edges safe to touch and free of sharp edges and burrs.
 - 1. Form body panels, doors, shelves, and accessories from one-piece steel sheet unless otherwise indicated.
 - 2. Provide fasteners, filler plates, supports, clips, and closures as required for complete installation.
- B. Fabricate each metal locker with an individual door and frame; individual top, bottom, and back; and common intermediate uprights separating compartments.
- C. Equipment: Provide each locker with an identification plate and the following equipment:
 - 1. Single-Tier Units: Shelf, one double-prong ceiling hook, and two single-prong wall hooks.
- D. Knocked-Down Construction: Fabricate metal lockers by assembling at Project site or preassembling at plant prior to shipping, using manufacturer's nuts, bolts, screws, or rivets.

- E. Welded Construction: Factory preassemble metal lockers by welding all joints, seams, and connections; with no bolts, nuts, screws, or rivets used in assembly of main locker groups. Factory weld main locker groups into one-piece structures. Grind exposed welds smooth and flush.
- F. Accessible Lockers (ADA): Fabricate as follows:
 - 1. Locate bottom shelf no lower than 15 inches above the floor.
 - 2. Where hooks, coat rods, or additional shelves are provided, locate no higher than 48 inches above the floor.
 - 3. Sloping-top corner fillers, mitered.
 - 4. Provide a minimum of 5percent of quantity for each locker type per room, minimum of one to meet ADA.
- G. Recess Trim: Fabricated with minimum 2-1/2-inch face width and in lengths as long as practical; finished to match lockers.
- H. Filler Panels: Fabricated in an unequal leg angle shape; finished to match lockers. Provide slip-joint filler angle formed to receive filler panel.
- I. Boxed End Panels: Fabricated with 1-inch-wide edge dimension, and designed for concealing fasteners and holes at exposed ends of nonrecessed metal lockers; finished to match lockers.
 - 1. Provide one-piece panels for double-row (back-to-back) locker ends.
- J. Finished End Panels: Fabricated to conceal unused penetrations and fasteners, except for perimeter fasteners, at exposed ends of nonrecessed metal lockers; finished to match lockers.
 - 1. Provide one-piece panels for double-row (back-to-back) locker ends.
- K. Center Dividers: Full-depth, vertical partitions between bottom and shelf; finished to match lockers.

2.6 ACCESSORIES

- A. Fasteners: Zinc- or nickel-plated steel, slotless-type, exposed bolt heads; with self-locking nuts or lock washers for nuts on moving parts.
- B. Anchors: Material, type, and size required for secure anchorage to each substrate.
 - 1. Provide nonferrous-metal or hot-dip galvanized anchors and inserts on inside face of exterior walls, and elsewhere as indicated, for corrosion resistance.
 - 2. Provide toothed-steel or lead expansion sleeves for drilled-in-place anchors.

PART 3 - EXECUTION

3.1 EXAMINATION

- A. Examine walls and floors or support bases, with Installer present, for compliance with requirements for installation tolerances and other conditions affecting performance of the Work.
- B. Prepare written report, endorsed by Installer, listing conditions detrimental to performance of the Work.
- C. Proceed with installation only after unsatisfactory conditions have been corrected.

3.2 INSTALLATION

- A. Install lockers level, plumb, and true; shim as required, using concealed shims.
 - 1. Anchor locker runs at ends and at intervals recommended by manufacturer, but not more than 36 inches o.c. Using concealed fasteners, install anchors through backup reinforcing plates, channels, or blocking as required to prevent metal distortion.
 - 2. Anchor single rows of metal lockers to walls near top and bottom of lockers of lockers and to floor.
 - 3. Anchor back-to-back metal lockers to floor.
- B. Knocked-Down Lockers: Assemble with manufacturer's standard fasteners, with no exposed fasteners on door faces or face frames.
- C. Welded Lockers: Connect groups together with manufacturer's standard fasteners, with no exposed fasteners on face frames.
- D. Equipment:
 - 1. Attach hooks with at least two fasteners.
 - 2. Attach door locks on doors using security-type fasteners.
 - 3. Identification Plates: Identify metal lockers with identification indicated on Drawings.
 - a. Attach plates to each locker door, near top, centered, with at least two aluminum rivets.
 - b. Attach plates to upper shelf of each open-front metal locker, centered, with a least two aluminum rivets.
- E. Trim: Fit exposed connections of trim, fillers, and closures accurately together to form tight, hairline joints, with concealed fasteners and splice plates.
 - 1. Attach recess trim to recessed metal lockers with concealed clips.
 - 2. Attach filler panels with concealed fasteners. Locate filler panels where indicated on Drawings.
 - 3. Attach sloping-top units to metal lockers, with closures at exposed ends.

4. Attach boxed end panels using concealed fasteners to conceal exposed ends of nonrecessed metal lockers.
5. Attach finished end panels using fasteners only at perimeter to conceal exposed ends of nonrecessed metal lockers.

3.3 ADJUSTING

- A. Clean, lubricate, and adjust hardware. Adjust doors and latches to operate easily without binding. Verify that integral locking devices operate properly.

3.4 PROTECTION

- A. Protect metal lockers from damage, abuse, dust, dirt, stain, or paint. Do not permit use during construction.
- B. Touch up marred finishes, or replace metal lockers that cannot be restored to factory-finished appearance. Use only materials and procedures recommended or furnished by locker manufacturer.
