ADDENDUM NO. 2

December 30, 2022

1. **Question:** On drawing MEP100 & drawing M503, Detail #4 does not appear to list the incoming gas pipe size into the regulator/meter prior to serving the boilers and generator on the boiler room side. Please confirm the incoming gas line size.

Response: The gas pipe size from the Gas Meter to the Boiler Room branch pipe size is 3".

- 2. **Question:** In regards to Addendum #1, Page # 2, Note 12 Response, who provides the sinks & faucets? **Response:** Sinks and Faucets are by the plumbing contractor.
- 3. **Question:** In regards to the Multi-Gas detector located in the apparatus room that operates the Plymovent Exhaust System Is the Multi-Gas Detector being supplied by the owner. Please provide that information **Response:** The Multi-gas detection system and interconnection to the Plymovent Exhaust System is by the Mechanical Contractor.
- 4. The HVAC contractor shall list a Price to deduct his Scope of Work for the Snow Melt System.
- 5. The General contractor shall list a Price to deduct his Scope of Work for the Snow Melt System.
- 6. A correction from Addendum #1, The Sprinkler Contract IS under the Plumbing Contracts work.
- 7. Question: Can you clarify the scope of work for Alternate #4. Mechanical drawing E602 says pumps 2, 6, and 8 are part of alternate 4 but electrical drawing E600 shows pumps 2, 4, 5, 8, 12 to be part of alternate 4.

 Response: If Alternate #1 is not taken but alternate #4 is taken the Spare Pumps for removal should be Pumps 2, 4, 5, 8, 12.
- 8. See the attached Revised Electrical Specifications & Table of Contents. Note: Section 263213 updated, Section 280513 added, 283111 added.
- 9. Correction on Addendum #1, the year date should be 2022, not 2020.
- 10. In reference to Item# 9 on Addendum #1, there will be no water meter required at this location.
- 11. In reference to Item# 10 on Addendum #1, the color of the Rack shall be one of the standard provided colors of the manufacturer.
- 12. In reference to Item# 14 on Addendum #1, this to clarify that the GC will the gas main up to the building edge where Central Hudson will provide a standard meter stand. The HVAC contractor will coordinate with Central Hudson standard requirements and also run the gas line into the building.
