1. INTRODUCTIONS

1) Copy of the Pre-Bid Meeting Agenda and Pre-Bid Meeting Sign-in Sheet are attached to these Meeting Minutes.

2) Bid Distribution:

The Rockland County Purchasing Division officially distributes bidding documents through the Empire State Purchasing Group Bid Notification System, referred to as BidNet, www.bidnetdirect.com.

Only those vendors who obtained bidding documents from the Empire State Bid Notification System are guaranteed to receive addendum information if such information is issued.

Copies from any other source are NOT considered official copies.

2. BID PRICES & BID PROPOSAL

A. Bid Prices

1. Bid Prices shall include costs for furnishing all labor, materials and tools, equipment and performance of all services required to complete the Contract work, in conformance with the Contract Documents.

The Contract Lump Sum Bid Prices shall include all Work, including all Work relating to the listed quantities of concrete repairs shown in the Contract Documents. Any quantities of concrete repair work items exceeding the listed quantities shown in the Contract Documents shall be paid for by Unit Price Items in the quantities listed in the Schedule of Bid; the quantities listed for the Unit Price Items in the Schedule of Bid are estimates and may differ from the actual materials in the field.

2. In computing the Bids, bidders are <u>not</u> to include the Sales and Compensating Use Taxes of the State of New York, or of any City and County in the New York State, for any supplies or materials to be sold to Rockland County Sewer District No. 1, which is exempt from such taxes.

B. Bid Proposal

1. Bid Security

a. Each proposal must be accompanied by a certified check for a sum equal to five percent (5%) of the amount of the Bid, payable to Rockland County Sewer District No. 1., or a Bid Bond on the form provided in the Contract Documents.

2. Bid Forms

- a. Bids shall be submitted on the Proposal Form furnished with the Contract Documents.
- b. All blank spaces for Bid Prices shall be filled in, in ink or typed, and in both Words and Figures.
- c. The Bid Proposal Forms shall be duly executed by the undersigned and attached to the Bid Proposal.
- d. Each Bidder shall submit references and a statement of the Bidder's Qualifications, including construction experiences and organization and equipment available for the work contemplated within the Bid Proposal.

3. QUESTIONS DURING BID, BID ADDENDUM, & BID OPENING

A. Questions During Bid

 The solicitation # must be included in the subject line of the email communication. The deadline for receipt of questions is 12:00 pm local time on August 22, 2024.

B. Bid Addendum

- 1. The Pre-Bid Meeting Minutes will be issued through Addendum No. 01 and posted to BidNet after the Pre-Bid Meeting.
- 2. Responses to all questions received during the Bid period will be issued through Addenda and posted to BidNet.
- 3. All Bidders shall acknowledge receipt of all Addenda by listing the Addenda in the Proposal Form.

C. Bid Opening

Bid Proposals for Contract RFB-RC-SWR-2023-06, Screening Improvements Project will be received on August 29, 2024 until 3:00 pm local time, in the Offices of the Department of General Services – Purchasing Division, 50 Sanatorium Road, Building A, 6th Floor, Pomona, NY 10970, at which time and place they will be publicly opened and read aloud.

All Bid Proposals shall be submitted in sealed envelopes and shall be plainly marked on the outside with the statement "Bid Documents Enclosed", Title of Project, Contract Name, and Bidder's Name and Address.

The Rockland County Purchasing Division will conduct this public bid opening. Any Bid Proposals not delivered in person shall be delivered by mail (preferably registered) to the Purchasing Division at the address below:

When sent by mail, the sealed proposal, marked as above, should be enclosed in an additional envelope similarly marked and addressed to the address above.

Bid Proposals received prior to the time of opening will be securely kept unopened. Bid Proposals received thereafter will be returned unopened.

4. OTHER REQUIREMENTS

A. Insurance & Bond Requirements

- 1. Upon award of the contract, the Contractor shall provide insurance certificates naming <u>both</u> the County of Rockland and Rockland County Sewer District No. 1 as Additional Insured.
 - Three (3) Certificates of Insurance and one (1) certified copy of the insurance policy or policies shall be provided within ten (10) calendar days of receipt of Notice of Award:
 - a. General Liability ACORD Certificate of Insurance naming <u>both</u> the Owner (Rockland County Sewer District No. 1) and the County of Rockland, both as Additional Insured and as Certificate Holders.
 - b. New York State Worker's Compensation Insurance.
 - c. New York State Disability Insurance.
- 2. Upon acceptance of the Bid, a successful Bidder will execute the Contract and furnish a properly executed Performance Bond and Payment Bond, each in an amount equal to one hundred percent (100%) of the Contract Price, within five (5) calendar days of the Notice of Award of the Contract.

B. Project Labor Agreement

1. A Project Labor Agreement is required to be entered into in connection with the construction of this Project. The form of the Project Labor Agreement that the Contractor will follow is attached as Appendix A of the Appendices package supplied to Bidders. The Owner will enter into the Project Labor Agreement with the Trade Council Associates.

In accordance with the requirements of the Project Labor Agreement, each Bidder must submit with its Bid a separate sealed list that names each subcontractor that the Bidder will use to perform Work on the Contract and the agreed-upon amount to be paid to each, for: (a) plumbing and gas fitting, (b) steam heating, hot water heating, ventilating and air conditioning apparatus, and (c) electric wiring and standard illuminating fixtures.

C. State and Federal Wage Rates

- 1. NYSDOL Prevailing Wage Rates
 - a. The Labor Law requires public work contractors and subcontractors to pay laborers, workers, or mechanics employed in the performance of a public work contract not less than the prevailing rate of wage and supplements (fringe benefits) in the locality where the work is performed.

2. Davis-Bacon Wage Rates

- a. The Davis-Bacon Act requires Contractors and Subcontractors performing construction, alteration, and repair work under Contracts in excess of \$2,000 funded from SRF and/or Federal monies, to pay their laborers and mechanics not less than the prevailing wage and fringe benefits for the geographic location.
- b. The Davis-Bacon wage determination for the locality in which this Contract takes place is included in Appendix C of the Contract Documents. To ensure the Davis-Bacon wage determination remains current, any modifications to the Davis-Bacon wage determination during the Bid period will be issued through Addenda.
- D. Equal Employment Opportunity Goals
 - 1. Refer to Appendices D and E included in the Contract Documents.
- E. CWSRF/NYSEFC Conditions & Requirements
 - 1. Refer to Appendices C through E included in the Contract Documents.
 - 2. Compliance with American Iron and Steel (AIS) is required.
- F. USEPA Grant Requirements
 - 1. Compliance with AIS is required.

5. CONTRACT SCHEDULE & COMPLETION TIME

- A. Notice of Award of Contract
 - 1. Notice of Award of the Contract will be made to the successful Bidder within 45 days after the opening of Bids.

B. Notice to Proceed

- 1. Notice to Proceed will be issued within fourteen (14) days of formal execution of the Contract.
- 2. The Contractor shall commence Work on the Contract within 10 days of the Notice to Proceed.

C. Contract Completion Time

1. Contractor must complete all Contract work within seven hundred sixty (760) consecutive calendar days from the date of Notice to Proceed.

6. PROJECT DESCRIPTION & SCOPE OF WORK

A. Service Area and Location

1. The work is located at Rockland County Sewer District No. 1 Wastewater Treatment Plant, 4 Route 340, Orangeburg, NY 10962.

B. Scope of Work

- 1. Replacement of climber type mechanical screens with three (3) multi-rake type bar screens.
- 2. Replacement of serpentine type belt conveyor with screw screenings conveyor.
- 3. Installation of new screenings compactor.
- 4. Construction of new Compactor Room building adjacent to existing Screen Building, consisting of a reinforced concrete spread footing, reinforced concrete slab on grade, combination concrete and concrete masonry unit (CMU) block walls with a brick façade, and reinforced concrete roof slab and roof beams.
- 5. Site grading and replacement of the asphalt driveway to the new Compactor Room.
- 6. Rehabilitation of the existing Screening Loading Area for use as an equipment storage and maintenance area.
- 7. Replacement of 2-inch bypass bar racks with 1-inch bar racks.
- 8. Replacement of slide gates.
- 9. Installation of stop logs, guides, and storage racks.
- 10. Replacement of gas detection system.
- 11. Replacement of lighting.
- 12. Replacement of facility doors and windows.
- 13. Sandblast and coating of existing structural roof beams.
- C. Replacement of Screen Building HVAC system, including ventilation supply and exhaust fans, louvers, ductwork, unit heaters, and controls, up to the point it connects to the Odor Control system.

The Pre-Bid Meeting ended at 10:20 AM and was followed by a Site Tour.

These minutes will be considered an accurate accounting of discussion, decisions, and directives agreed to during this meeting, and will be made part of the permanent project record.

The attention of all proposers is directed to the following changes, additions, and/or substitutions affecting the above-referenced project. This addendum shall be included in and become part of the RFB for this project. Acknowledge receipt of this addendum in the space provided in the Proposal Form; this section must be signed and submitted with the bid proposal. Failure to do so, may subject the bidder to disqualification.

Below are the questions that have been submitted with Responses from the Owner:

Question 1:

Instruction to bidders item 27 for utilization of MWBE's - indicates good faith effort of 10% Minority and 6% Women. Section III.A.1 of the Mandatory SRF Terms and Conditions indicate a 20% MWBE participation goal. Please advise which goal is correct.

Response: Refer to Appendix D: NYSEFC Mandatory State Revolving Fund Terms and Conditions and Appendix E: Guidance for Mandatory State Revolving Fund Terms and Conditions for MWBE requirements for this project.

Question 2:

Appendix F contains NYSEFC mandatory SRF terms and conditions. Section 3 Certified Service Disabled Veteran Owned Business (SDVOB) participation opportunities indicates the requirements of this section apply to all construction contracts and subcontracts. Please advise if SDVOB participation will be required and what the percentage of good faith goals will be if required.

Response: Appendix D: NYSEFC Mandatory State Revolving Fund Terms and Conditions and Appendix E: Guidance for Mandatory State Revolving Fund Terms and Conditions discuss SDVOB requirements for this project. Appendix D, Section 3 encourages the Contractor to make a good faith effort to promote and assist in the participation of SDVOBs and contains contact information for assistance.

Question 3:

Invitation to bidders, Article 30.C, item 6 & 7 "All bidders will be required to complete the NYS Department of Environmental Conservation Performance bond information form in the proposal portion of this specification." Please provide further clarification of the NYSDEC bond requirements and referenced associated form is not apparent in the provided documents.

Response: Bidders should disregard the references in Article 30.C Items 6 and 7 regarding NYSDEC bond requirements for this project.

Question 4:

Confirm that with a Project Labor Agreement (PLA) that General Condition Article 68 compliance with Local Law 17 & 10 remains in effect for Licensed Electrical/HVAC/Plumbing.

Response: The General Contract Conditions Article 68 pertaining to Permits and Licenses do apply for this Project Labor Agreement (PLA) project. The Contractor shall possess a valid County of Rockland license for the trades required for the work as of the date of the opening of the Bids.

Question 5:

The holidays called out in the PLA and holidays listed in article 56 of the General Contract Conditions don't match. Please advise if the contractor should follow the GCC article 56 holidays or the PLA holidays.

Response: The Holidays listed in the Project Labor Agreement (PLA) are the holidays that will apply to this project.

Question 6:

Instructions to Bidders 3. requires the Bid Bond to be signed by a Resident Agent. Kindly consider allowing signature by a Non-Resident Agent, as resident agent countersignature laws have been eradicated throughout the United States. Any bid, performance, or payment bond that requires a resident agent countersignature or a resident agent signature violates law. Please remove the requirement for a resident agent countersignature.

Response: The Contract requirement will not be changed.

Question 7:

Instructions to Bidders 3. gives the Owner the right to recover the greater of the entire amount of the Bid Security or ten percent of the Bid, or to exercise any and all equitable remedies it may have against the defaulting Bidder in the event of the bidder's failure to timely submit all additional information requested by Owner, or if the successful Bidder fails to timely and properly submit all required Bonds, certificates and policies of insurance, or if the successful Bidder fails to timely and properly execute the Contract, the Contractor's Certification and all other required documentation related to the Contract. It is the intention of the Bid Security to provide the Owner a means of recovery in the event of a failure on the part of the Bidder. The Owner's recovery should be limited to the amount of the Bid Security. Further it is not equitable to allow the Owner to exercise any and all equitable remedies it may have against the defaulting Bidder as again, the Bid Security should be the agreed upon remedy.

Please amend to: "If the successful Bidder fails to timely submit all additional information requested by Owner, or if the successful Bidder fails to timely and properly submit all required Bonds, certificates and policies of insurance, or if the successful Bidder fails to timely and properly execute the Contract, the Contractor's Certification and all other required documentation related to the Contract, it will be difficult and impracticable to ascertain and determine the amount of damage that Owner will sustain by reason of any such failure. For such reason, every Bidder shall, by submitting its Bid, be deemed to agree that

Owner shall have the right, at its option in the event of any such default, to retain or recover as reasonably estimated liquidated damages, and not as a penalty, the entire amount of the Bid Security or ten percent of the Bid, whichever is greater, or to exercise any and all equitable remedies it may have against the defaulting Bidder."

Response: The Contract requirement will not be changed.

Question 8:

General Contract Conditions 52. requires the Contractor to maintain the sole risk of the work from commencement until final payment. Builder's risk coverage ends upon Substantial Completion or when the Work is put to its intended use, whichever occurs earlier. It is not equitable to give the Contractor the risk for loss it cannot insure. Contractor's risk of loss should end upon Substantial Completion or at the point the Work is put to its intended use by the Owner, whichever is earlier.

Please amend to: "The Work and everything pertaining thereto shall be provided, performed, completed, and maintained at the sole risk and cost of Contractor from the commencement of the Work until final payment Substantial Completion or at the point the Work is put to its intended use by the Owner, whichever is earlier."

Response: The Contract requirement will not be changed.

Question 9:

General Contract Conditions 105. requires the Contractor to furnish a certified copy of the original policy as soon as practicable prior to payment. Contractor is a large, sophisticated entity whose corporate policies insure all operations in the United States. Providing complete copies of a corporate policy is an onerous and unnecessary requirement. Per market precedence, certificates of insurance with applicable endorsements should suffice.

Please amend to: "The Contractor shall furnish to the Owner, a certified copy of the original policy certificate of insurance, with an endorsement naming the Owner and the County of Rockland as Additional Insured, as soon as is practicable and as a condition prior to payment."

Response: The Contract requirement will not be changed.

Question 10:

General Contract Conditions 105. requires any and all subcontractors to carry the same insurance as required in the specifications, including a \$10,000,000 excess umbrella. These coverages and limits may not be commercially available or would be cost prohibitive to most subcontractors, particularly the SBE and DBE subcontractors.

Please amend to: "...The Contractor's insurance policy shall cover all the work performed by his subcontractor(s). 

- GROUP 4: Drivers on tri axles, ten-wheelers, grease trucks and tillermen.
- GROUP 5: Drivers on pick-up trucks used for materials & parts, drivers on escort man over-the-road and drivers on straight trucks.

WELDERS - Receive rate prescribed for craft performing operation to which welding is incidental.

** Workers in this classification may be entitled to a higher minimum wage under Executive Order 14026 (\$17.20) or 13658 (\$12.90). Please see the Note at the top of the wage determination for more information. Please also note that the minimum wage requirements of Executive Order 14026 are not currently being enforced as to any contract or subcontract to which the states of Texas, Louisiana, or Mississippi, including their agencies, are a party.

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

State Adopted Rate Identifiers

Classifications listed under the ""SA"" identifier indicate that the prevailing wage rate set by a state (or local) government was adopted under 29 C.F.R �1.3(g)-(h). Example: SAME2023-007 01/03/2024. SA reflects that the rates are state adopted. ME refers to the State of Maine. 2023 is the year during which the state completed the survey on which the listed classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 01/03/2024 reflects the date on which the classifications and rates under the ?SA? identifier took effect under state law in the state from which the rates were adopted.

WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
- * an existing published wage determination
- * a survey underlying a wage determination
- * a Wage and Hour Division letter setting forth a position on a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:

2.) If the answer to the question in 1.) is yes, then an interested party (those affected by the action) can request review and reconsideration from the Wage and Hour Administrator (See 29 CFR Part 1.8 and 29 CFR Part 7). Write to:

The request should be accompanied by a full statement of the interested party's position and by any information (wage payment data, project description, area practice material, etc.) that the requestor considers relevant to the issue.

3.) If the decision of the Administrator is not favorable, an interested party may appeal directly to the Administrative Review Board (formerly the Wage Appeals Board). Write to:

4.) All decisions by the Administrative Review Board are final.
