Refer to dwg T-100, Notes, note # 13. Dependent on the submitted project schedule, the intent is to start the work in October and get it completed before the end of the year so that there is no need for temp. cooling. For heat, there is perimeter heat. Coordinate with subcontractors.

After checking with the FM team on this matter, they said that there is actually a temp panel in the mechanical room that could be used if heaters were needed if the temps drop. They also have 4 heaters that could be installed. This can be carried as an alternate cost which would cover mounting the heaters to the ceiling (brackets are in place) and

to connect them should they be needed. The perimeter heat is along the windows and FM said that if the outside temp is too low, the opposite side of the bank is not comfortable so the heaters may be needed.
