- Is there a separate GC budget? Does the contractor have to bid on all contracts?
   This project is being bid as five separate Prime Contracts GC, Site, Mechanical, Plumbing, and Electrical. GC budget is 22.25 million
- 2. Is there preapproval required to bid work for White Plains Board of Education? There is no preapproval from White Plains Schools.
- 3. Is the walkthrough on 4/25 mandatory?

Bid walk throughs are not mandatory, there was a walk through held on 4/1 for exterior. There will be another for the interior on 4/8 @ 3 pm. Meeting point is at the front entry of the high school.

- 4. Do I need to sign up for the pre bid meeting? Bid walk throughs are not mandatory.
- 5. What is the scope of work for this project?

The scope is the construction of a new ±48,000 sf, 2 story addition with connections and tie-ins to the existing building.

- 6. Notice to Bidder and Construction milestones indicate two different dates. Bid date is 4/23. Construction milestone to be updated accordingly.

- 8. Who is responsible for temporary heating? Contract G as stated in the special provisions.
- Who is responsible for dumpsters?
   Responsibility of the dumpsters are identified in the special provisions. See item 1 for each Prime contractor under heading.
- 10. How is the owner is going to purchase the kitchen equipment?

  Since the equipment is not required for at the moment, the Kitchen Equipment will be bid at a later date.
