## **GENERAL CLARIFICATION TO Project:**

- The bid deadline has been extended to Friday, April 25, 2025. Sealed Proposals will be received until 1:00pm at the White Plains City School District Office main entrance security desk, located at 5 Homeside Lane White Plains, NY 10605. Note that the location of the bid opening did not change.
- Clarification for Contract G: Specification sections 084113.13 FIRE RATED ALUMINUM AND GLASS FRAMING SYSTEMS and 084113.16 – FIRE RATED GLASS AND FRAMING SYSTEMS are for rated aluminum and glass window and/or door assemblies. Architectural Drawings A 100, A 101, A102, A120, A620, and G 111 have been updated to identify the required locations of these rated assemblies.
- 3. Clarification for Contract G: Architectural Drawings A102, A 120 and G111 have been updated to identify the locations of spray-applied fire-resistant materials.
- 4. Clarification for Contract C and Contract P: New domestic fire and service connections and piping, including all trenching, backfill and surface restoration from new connection within right-of-way to five (5) feet of building by Contact C. All work associated with the new service connections within five (5) feet on the building and inward by Contract P. Verbiage on drawings C 100 and PS 100 has been updated to reflect this.
- 5. Clarification for Contract E: The district shall provide a new fire alarm control panel 'FACP', only. Contract 'E' shall provide and install all new fire alarm devices and all necessary equipment to make a connection to the new fire alarm control panel "FACP" to existing "FACP". This includes all amplifiers/EVACs, expansion cards, wire, conduit, relays, power supplies, batteries, extenders, programming, mounting hardware, and junction boxes as required for a fully functioning system. All wire and terminations by Contract 'E'.
- 6. Clarification for Contract E: Refer to sheet M 102.03 for location of four (4) existing condensing units on the Northwest side of the existing building 'A' to be relocated by contract 'M' thirty (30) feet southwest of the current location. Contract 'E' shall disconnect associated disconnect switch and convenience receptacle and relocate to new location shown in sheet M 102.03. Provide, extend and/or modify existing wire and conduit as required to terminate to new location. Provide and install additional junction boxes and all mounting hardware and accessories as required. Wire and conduit shall be the following for each unit:
