- 1 REMOVE GYP. BD. WALL PARTITION WHERE INDICATED BY DASHED LINE, TYP.
- 2 REMOVE EXISTING ACCT. CEILING, GRID AND ELECTRICAL FIXTURES
- 3 REMOVE EXTERIOR LIGHT FIXTURE. SEE RCPs FOR NEW FIXTURES. PROVIDE COVER WHERE NO NEW FIXTURE SHOWN
- 4 REMOVE BORROWED LITE AND FRAME
- 5 REMOVE EXISTING MOVING PARTITION AND TRACK AND SOFFIT ABOVE
- 6 REMOVE CLERESTORY WINDOW AND PORTION OF SILL AND PREP FOR NEW SMALLER WINDOW AND MASONRY INFILL
- 7 REMOVE EXISTING FLOORING AND MASTIC, PREP FOR NEW SEE SPEC.
