C-02	CEILING	ROOM 103 CEILING IN THE MANOR HALL IS EXCLUDED FROM THE CONTRACT. CONTRACTOR NOT TO DISTURB CEILING. PROTECT IN PLACE.
C-03	CEILING	VENEER PLASTER CEILING. PRIME AND PAINT. PROTECT MEDALLION IN PLACE AT CENTER OF CEILING IN ROOM 104.
C-04	CEILING	PATCH CEILING. SCRAPE, PRIME AND PAINT CEILINGS

3. MINOR UPDATES TO EXISTING HVAC, REFER TO MECH. DWGS.
4. REPLACE LIGHTING 100%. TRACK LIGHTING LED - ALL EXCEPT PAPER MACHE CEILING (103) & STAIR HALLS. STAIR HALLS INSTALL DROP LIGHTS AT CEILING MODILLIONS. REFER TO ELEC. DWGS.
5. UPGRADE WIFI AND ETHERNET THROUGHOUT HOUSE
6. REPLACE FIRE DETECTION SYSTEM AND SECURITY SYSTEM. PROTECT & RETAIN CAMERAS. REFER TO ELEC. DWGS.
