




**PARTIAL ELECTRICAL RISER DIAGRAM** (2) E101 N.T.S.

- 1 PROVIDE 2#8+1#10G IN 3/4" CONDUIT TO CIRCUIT AS SHOWN. PROVIDE A 2P-30AMP BREAKER IN AVAILABLE AT PANEL BRP-1
- 2 PROVIDE A 60 AMP GE DOUBLE THROW FOUR WIRE 240 V SAFETY SWITCH MODEL # TC35322 WITH DS100GK GROUND KIT AND TRK100 NEUTRAL KIT. ONLY USE PHASE "A" AND "B". PHASE "C" WILL NOT BE USED.
- 3 PROVIDE KINDORF SUPPORT FOR EQUIPMENT.
- 4 PROVIDE A TRIPLE GANG BOX. BOX SHALL BE MOUNTED ON WALL.
- 5 PROVIDE WEATHERPROOF HUBBELL TWIST-LOCK PLUG RATED AT 125V/250V 30 AMPS PART # HBL2711 AND HUBBELL HBL2713 TO MATCH EXISTING PORTABLE GENERATOR OUTPUT RECEPTACLE. CONNECT WITH 3#8+1#10G GRD. PROVIDE A NEMA-3R INLET BOX HUBBELL PART # HBL2715M3. INLET BOX SHALL BE MOUNTED ON EXTERIOR WALL. PROVIDE WATER TIGHT BOX HUBBELL BOX PART # HBL608. PROVIDE ALL REQUIRED AND NECESSARY ACCESSORIES. PROVIDE WEATHERPROOF 2 GANG DEEP BOX WITH A LOCKABLE HINGED COVER. COORDINATE EXACT LOCATION OF ENCLOSURE AND OUTLET CONFIGURATION WITH OWNERS BEFORE THE START OF ANY WORK.
