


**1 DEMOLITION PLAN**  
1/4" = 1'-0"


- DEMOLITION NOTES**
1. PRIOR TO DEMOLITION, ARRANGEMENTS BY A LICENSED PLUMBER MUST BE MADE FOR EXISTING PLUMBING FIXTURES SUCH AS DRINKING FOUNTAINS, SINKS, ETC. TO BE REMOVED AND WATER SUPPLY SHUT OFF TO PREVENT FLOODING IN CASE OF DAMAGE DURING DEMOLITION.
  2. PRIOR TO DEMOLITION, ARRANGEMENTS BY AN APPROVED ELECTRICAL CONTRACTOR MUST BE MADE TO CUT OFF ELECTRIC POWER TO ALLOW REMOVAL OF EXISTING LIGHTING FIXTURES, ETC. TEMPORARY POWER AND LIGHT MUST BE PROVIDED IN AREA TO BE DEMOLISHED AND ALL SURROUNDING OCCUPIED AREAS MUST HAVE POWER MAINTAINED FOR NORMAL OPERATION.
  3. PUBLIC AREAS SUCH AS PUBLIC HALLS AND SERVICE HALLS SHALL BE PROTECTED AS DIRECTED BY THE OWNER.
  4. REROUTE & RECONNECT ALL CIRCUITING TO EXISTING LOADS WHICH ARE TO REMAIN IF DISTURBED BY DEMOLITION WORK. PROVIDE NEW HOME RUNS IF REQUIRED.
  5. CONDUITS COMING UP OUT OF THE FLOOR SLAB WHICH ARE TO BE REMOVED SHALL BE CUT BACK BELOW THE TOP OF FINISHED SLAB.
  6. DISCONNECT AND REMOVE ALL EXISTING WIRING AND EXPOSED CONDUIT NOT KEPT OR REUSED.
  7. RELOCATE ACTIVE OUTLET BOXES, JUNCTION BOXES, ETC WHICH WOULD BE LEFT INACCESSIBLE BY NEW CONSTRUCTION.
  8. PROVIDE EXTENSION COLLARS ON EXISTING OUTLETS WHERE THE AREA THEY ARE MOUNTED TO IS FURRED OUT.
  9. ALL EXISTING ELECTRICAL CIRCUITS ARE TO BE REUSED FOR NEW LIGHTING AND SWITCHING AND FANS



  3. LANDING AT TOP OF STAIR RUN TO RECEIVE RUBBER TILE FLOORING TO MATCH EXISTING IN COLOR AND RAISED PATTERN.
  4. CERAMIC TILE COVE BASE SHALL MATCH TILE SIZE, CUT TILE NOT ALLOWED.
  5. PROVIDE VINYL TRANSITIONS AT DISSIMILAR FLOOR FINISHES UNLESS OTHERWISE NOTED.
  6. PATCH TO MATCH CEILINGS, WALLS AND FLOOR AT NEW D.F. AREA AND NEW J.C.




**3 REFLECTED CEILING PLAN**


