It was discussed with Tom from the City of Yonkers School District that one of the existing data cables could be utilized for the required new data cable (Scope of Work line item 5c). It was further discussed to include testing and certification for one of the existing data cable/jacks for use with the new BMS Local Control Panel (LCP) with extension of the existing data cable to the new LCP in the Base Bid and providing an Alternate for the new CAT 6 data cable from the second floor data closet to the new LCP in the Custodians Office. Please advise of any Scope of Work and Bid Schedule of Prices revisions.

**City Response:** Disregard what was discussed in the field and provide as specified for the Scope of Work Items 5.C. Existing cable jacks will not be used.
