THE QSD WILL ACT AS A DATA SUBMITTER FOR THE VA WITH THE FILING OF THE NOTICE OF INTENT TO THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION FOR COVERAGE UNDER THE CONSTRUCTION GENERAL PERMIT. THE CONTRACTOR SHALL BE RESPONSIBLE TO PAY ALL FEES ASSOCIATED WITH THIS PERMIT, WHICH INCLUDE, BUT ARE NOT LIMITED TO, THE NOTICE OF INTENT FILING AND ANNUAL FEES FOR MAINTAINING COVERAGE UNDER THIS PERMIT. THE CONTRACTOR WILL BE RESPONSIBLE FOR REVIEWING AND IMPLEMENTING THE PROVISIONS SPECIFIED IN THE SWPPP AND THE EROSION CONTROL PLANS. THE CONTRACTOR SHALL ALSO PROVIDE A "QUALIFIED SWPPP PRACTITIONER" (QSP) WHO WILL BE RESPONSIBLE FOR IMPLEMENTING THE SWPPP, AND WILL ASSIST THE VA IN THE FILING OF A NOTICE OF TERMINATION TO THE STATE WATER RESOURCES CONTROL BOARD AT THE END OF THE PROJECT.


