




- GENERAL NOTES**
- CONTRACTOR SHALL BE RESPONSIBLE FOR IDENTIFICATION OF ALL RATED WALLS, CEILINGS AND SLABS AND THEIR SPECIFIED RATING ON THE ARCHITECTURAL DRAWINGS. ALL DEVICES AND MATERIALS SHALL MEET THE UL RATINGS OF THE RATED WALLS, CEILINGS AND SLABS ASSEMBLY. CONTRACTOR SHALL PROVIDE AN ASSEMBLY INSTALLED IN ACCORDANCE WITH THE RATED APPLICATION.
 - ALL OCCUPANCY/VACANCY SENSORS SHALL TURN OFF WITHIN 20 MINUTES OF THE SPACE BECOMING UNOCCUPIED.
 - OCCUPANCY SENSORS SHALL FAILSAFE "ON".
 - ALL COMMON AREAS SHALL BE CONTROLLED VIA LCP - LIGHTING CONTROL PANEL FOR DIMMING CONTROL OF THE LIGHTING. FOR SAFETY REASONS, THE FACILITY COMMON AREAS SHALL REMAIN "ON" 24/7. THE LIGHTING CONTROL PANEL WILL DIM THE LIGHTING DOWN TO 30% WHEN NO MOTION IS DETECTED IN THE SPACE. WHEN CEILING SENSORS DETECT MOTION, THE LIGHTING WILL DIM UP TO 100%.
 - WHERE MULTIPLE SWITCHES ARE SHOWN AT THE SAME LOCATION, THEY SHALL BE GANGED TOGETHER WITH A COMMON GANG FACEPLATE.
 - ALL LINE VOLTAGE WALL SWITCHES SHALL BE A PUSH BUTTON TYPE UNLESS OTHERWISE NOTED.
 - FOR EACH EXIT SIGN, CONTRACTOR SHALL PROVIDE UN-SWITCHED HOT FROM LIFE SAFETY CIRCUIT.
 - FIXTURES INDICATED WITH A "P" SHALL BE CONTROLLED VIA "DS" DAYLIGHT SENSOR. FIXTURE SHALL BE MOUNTED AT 10'-0" ABOVE FINISH FLOOR.
 - FIXTURE "Q" SHALL AIM TO THE ART ON WALL. COORDINATE EXACT LOCATION AND AIMING WITH ARCHITECT AND OWNER.
 - WALL SCONCES INDICATED WITH AN "H" SHALL BE MOUNTED 58" AFF AND VANITY FIXTURES INDICATED WITH A "B" SHALL BE MOUNTED 90" AFF UNLESS OTHERWISE NOTED.
