MC cable may not be used in any exposed locations or areas where it would be subjected to physical damage or where prohibited by Code.*

5. Can you clarify the base bid and alternate?
 - a. ***RESPONSE: The base bid scope is to complete the project during the school's summer break starting at the end of June. The intent behind the alternate is to provide the District with the option of completing the project in advance of the summer break, as soon as the equipment can be procured. In order to complete the project during the school year the work would have to be completed during 2nd shift or during school breaks when the students are not occupying the building.***
