

- PLUMBING DEMOLITION KEYNOTES:**
- (D1) THE CONTRACTOR SHALL DEMOLISH THE EXISTING PLUMBING FIXTURE AND ASSOCIATED BRANCH PIPING BACK TO MAIN AND CAP. PATH ALL OPENINGS. ALL WORK SHALL BE CAPPED BELOW THE SLAB SO THAT A SMOOTH FINISH CAN BE APPLIED TO THE SURFACE.
 - (D2) THE CONTRACTOR SHALL DEMOLISH AND CAP THE BRANCH PIPING BACK TO THE MAIN.
 - (D3) THE CONTRACTOR SHALL DEMOLISH PIPING AND CAP FOR FUTURE CONNECTION.
 - (D4) THE CONTRACTOR SHALL DEMOLISH THE EXISTING PLUMBING FIXTURE AND CAP PIPING FOR FUTURE CONNECTION.
 - (D5) EXISTING TO REMAIN.
 - (D6) THE EXISTING SEWAGE EJECTOR, PUMP BASIN, CHECK VALVES, SHUT-OFF, CONTROL PANEL, AND ALL ASSOCIATED DEVICES TO REMAIN.


- GENERAL PLUMBING DEMOLITION NOTES:**
1. IT SHALL BE THE RESPONSIBILITY OF THE DEMOLITION CONTRACTOR TO VISIT THE SITE IN ORDER TO BEST UNDERSTAND THE SCOPE OF THE DEMOLITION WORK.
 2. ALL DEMOLISHED MATERIALS SHALL BE RECYCLED WHEREVER POSSIBLE. ANY HAZARDOUS MATERIALS SHALL BE HANDLED ACCORDING TO GOVERNMENT REGULATION AND DISPOSED OF IN A SAFE MANNER.
 3. THE SCOPE OF PLUMBING DEMOLITION SHALL INCLUDE BUT NOT BE LIMITED TO THE FOLLOWING:
 - a. THE EXISTING SANITARY AND VENT SYSTEM INCLUDING PIPING, HANGERS, FITTINGS, SLEEVES, ETC.
 - b. THE EXISTING DOMESTIC WATER SYSTEM INCLUDING COLD WATER, HOT WATER SUPPLY AND HOT WATER RETURN PIPING, HANGERS, FITTINGS, SLEEVES, ETC.
 - c. EXISTING FIXTURES, FAUCETS, FLUSH VALVES, TRAPS, HANGERS, STOPS, ETC.
