**Description of Work: The project includes a Project Labor Agreement. All work shall be included under one contract for General Contracting.** The work includes but is not limited to: complete clearing of a wooded site and preparation of the site for the construction of a new animal shelter building including all site civil work, new site utilities, concrete foundation work, general construction work to provide for a complete building finished interior and exterior, construction of new mechanical, plumbing and electrical systems including sprinkler systems, F/A systems, telecommunication systems, etc., new parking area, site lighting and demolition of existing building including hazardous materials abatement, etc.

Bids are being solicited for one contract, General Contracting, inclusive of the Project Labor Agreement.

The total Contract Time from the issuance of the Notice to Proceed until total closeout of the project shall be **540 calendar days**. The Contract Time to perform the construction work shall be **420 calendar days** from the issuance of the Notice to Proceed to Substantial Completion.
