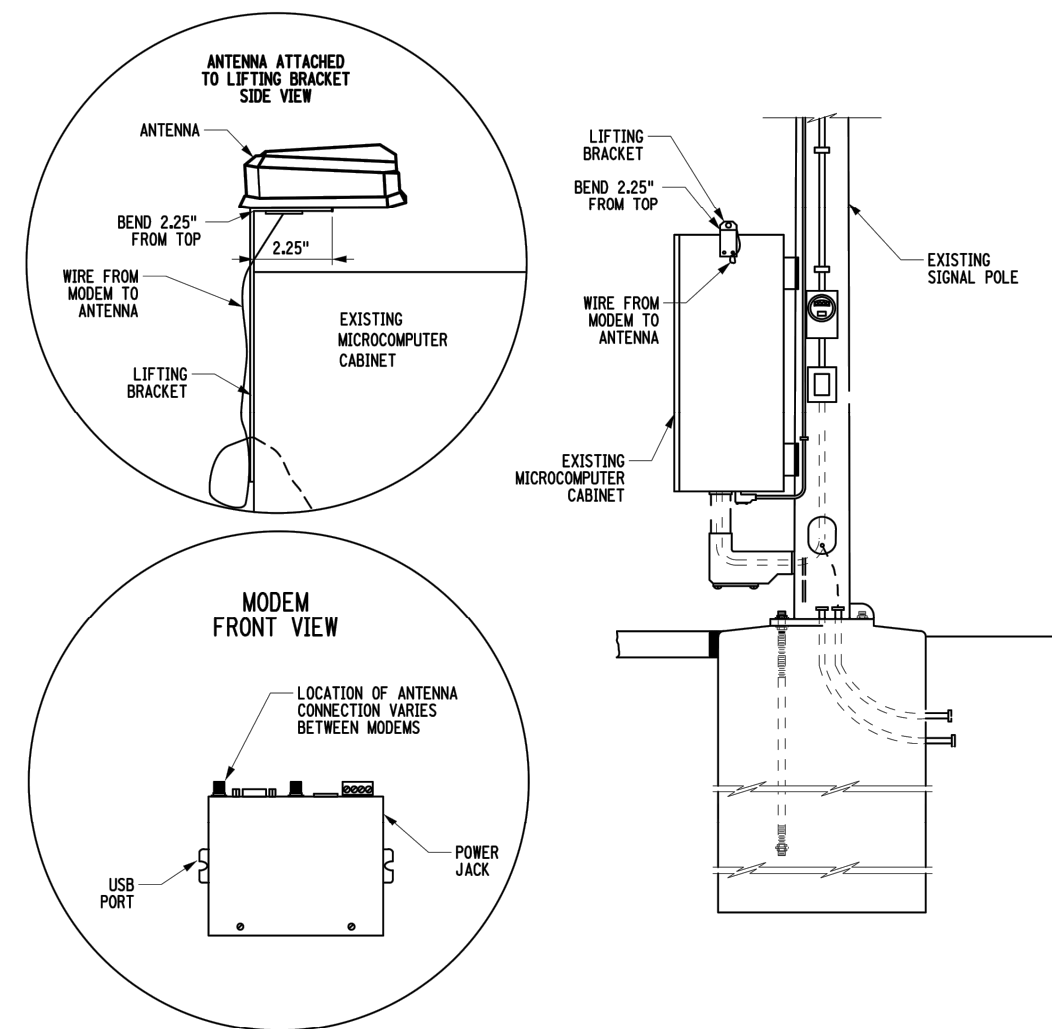


- NOTES:
1. ALL MOUNTING HARDWARE SHALL BE PROVIDED BY THE MANUFACTURER AND BE INCLUDED IN THE PRICE OF THE 360 DEGREE VIDEO DETECTION SYSTEM.
 2. ALL EQUIPMENT SHALL MEET THE CONTRACT SPECIFICATION. STYLE OF CAMERA AND HARDWARE MAY VARY BY MANUFACTURER.

- STEP 1. DETACH LEFT LIFTING BRACKET
STEP 2. DRILL THE FRONT HOLE OUT TO 3/8"
STEP 3. BEND BRACKET INTO AN L SHAPE TO HOLD THE ANTENNA, AT LEAST 2.25" FROM TOP
STEP 4. REINSTALL THE BRACKET WITH THE ANTENNA MOUNTED ON THE BRACKET
STEP 5. RUN WIRE THROUGH THE LARGER HOLE, LEAVE A DRIP LOOP, AND APPLY SILICONE INSIDE AND OUTSIDE CABINET WALLS
STEP 6. INSTALL MODEM ON THE UPPER SHELF AND SECURE ALL CABLES

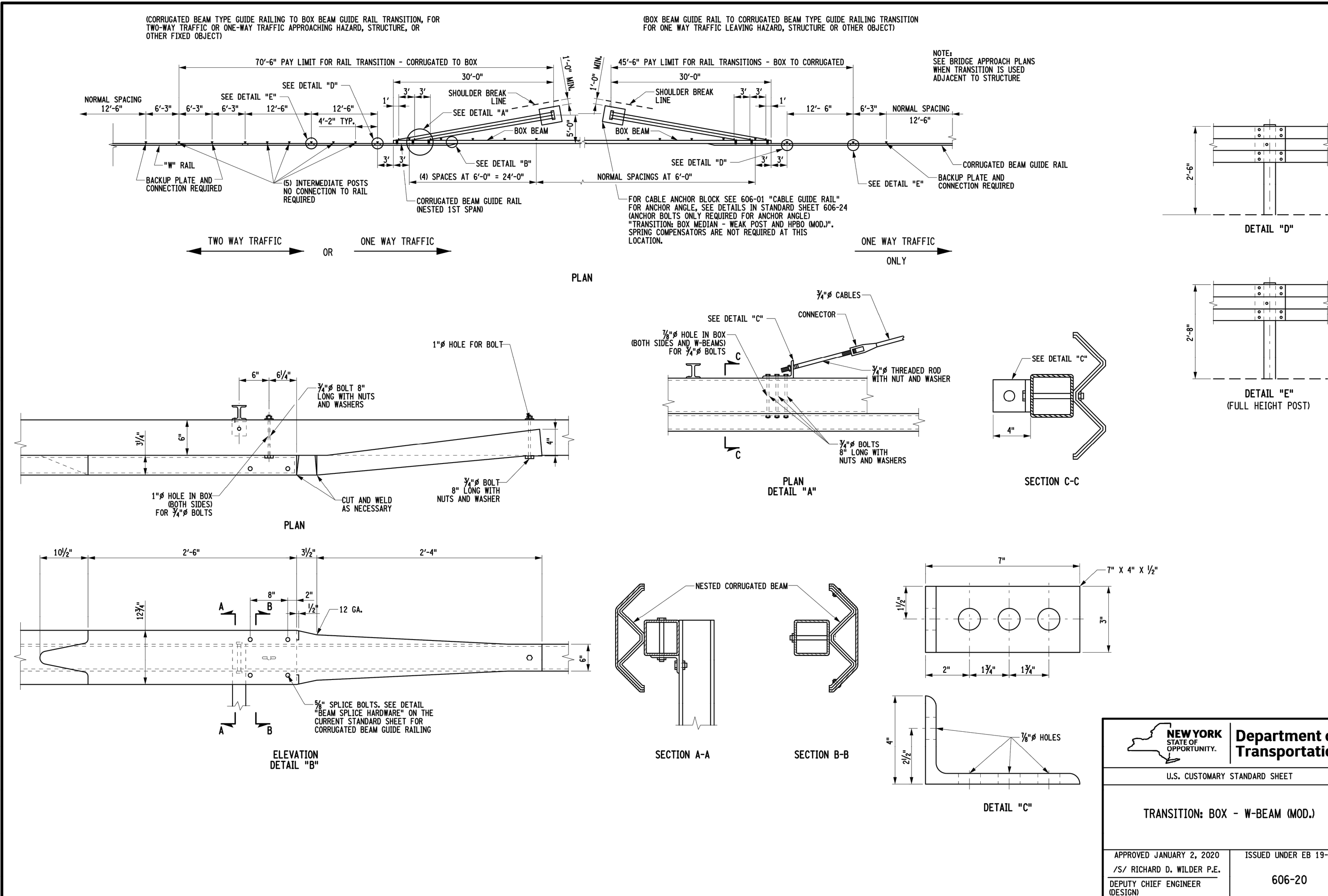

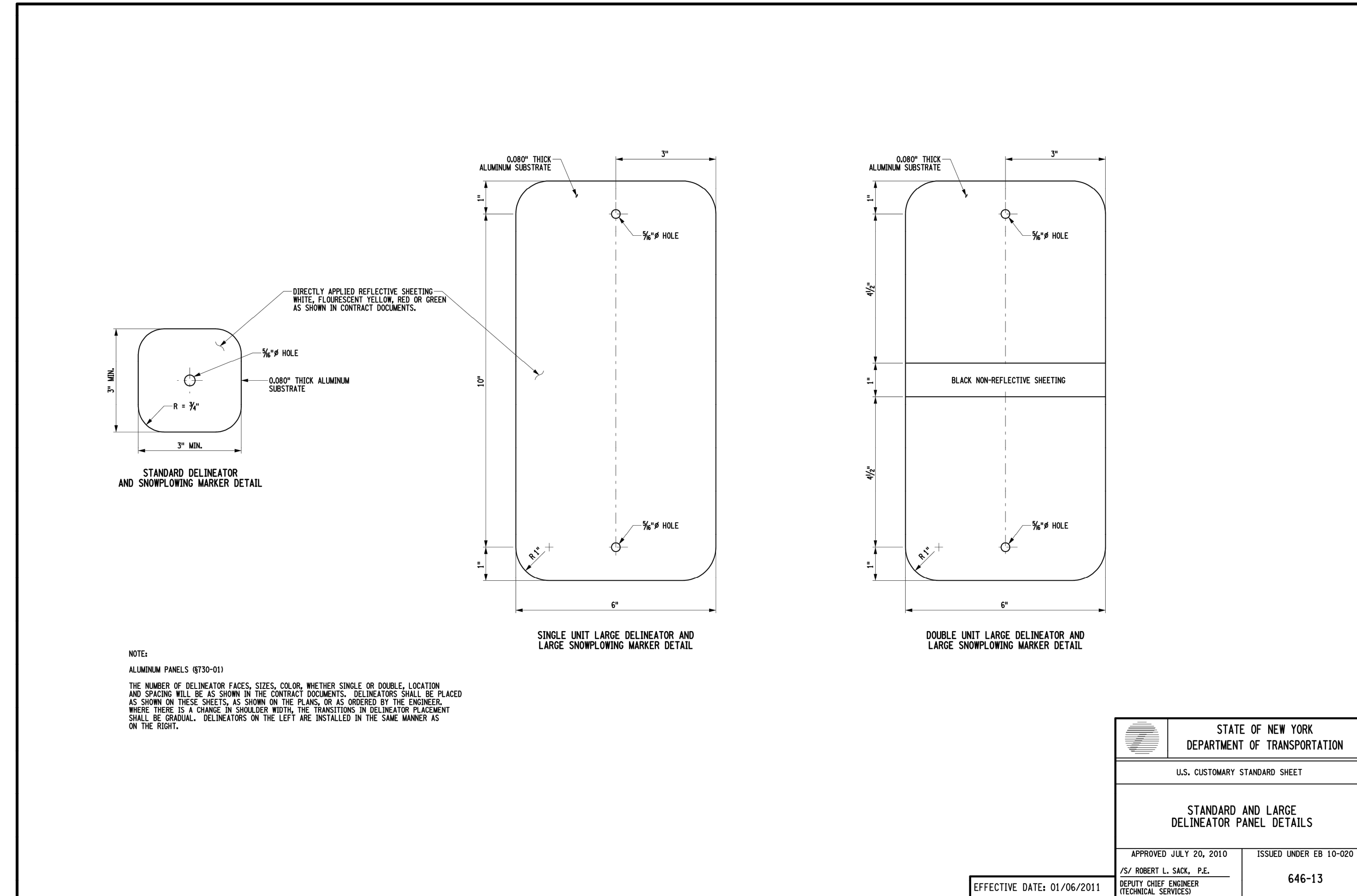

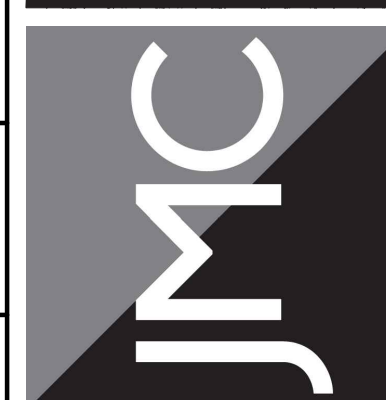
