Item No. 1- Questions

Below are the Questions that have been submitted with responses from the Owner:

Question #1:

- 1. Questions from an HVAC subcontractor regarding specification 15855 Split System:
 - a. Is a complete BMS/ATC system required?
 - b. Does Rockland County have a preferred or an in-house vendor for the BMS/ATC System as described?

Response: Delete Part 2.04.D from Specification Section 15855.

Question #2:

Regarding the seal water piping, the riser diagrams on drawing P-001 indicate 1/2'' copper piping to the pumps. However, Drawings P-101 and P-201 indicate 1'' copper. Please clarify.

Response: On Sheet P-001 Seal Water Riser Diagram, <u>Replace</u> callout for both pump stations to state "1" SS TO PUMPS FOR SEAL WATER (TYP. OF 4)."

Question #3:

Please provide a detailed drawing showing how the connection is to be made to the stuffing box area including the pipe size diameter we are to provide be it $\frac{1}{2}$ or 1" stainless steel.

Response: Contractor shall coordinate with pump manufacturer on the connection to the stuffing box.

In Specification Section 15855, Delete Part 2.04.D.

Item No. 3

On Sheet P-001 Seal Water Riser Diagram, Replace callout for both pump stations to state "1" SS TO PUMPS FOR SEAL WATER (TYP. OF 4)."
