Faxed bids will NOT be accepted. Bids must be in sealed envelope(s) approximately labeled with the following label:

- 3) The North Rockland Central School District is exempt from sales tax.

- 6) Addendum #1 says all items required to be removed/demolished that are not required to be abated shall be removed by the HVAC Contractor. Who is removing the boilers from the space as they are marked as PACM?  
**Answer: Abatement Contractor will disassemble and remove.**
- 7) Is the HVAC Contractor responsible for trenching, backfilling, and landscape restoration for the removal of fuel oil piping and oil tank removal?  
**Answer: Owner will hire oil tank removal company directly. Oil tank removal company is responsible for the removal, excavation, and restoration.**
- 8) Is the HVAC Contractor responsible for the new concrete pads inside the boiler room?  
**Answer: HVAC Contractor is responsible for all electrical and general scope. See specification section “Multiple Contract Summary 011200”**
- 9) Is the HVAC Contractor responsible for the fence work (Note C3 Drawing C-101)?  
**Answer: HVAC Contractor will repair existing chain link fence.**
