- The contractor is to remove all existing supply and return ductwork from bank and to the existing 30-ton air handler in the basement above the ceiling.
- Contractor to disconnect and abandon the 30-ton air handler in the basement in place.
- The exhaust ductwork is to remain and be reused.
- The existing condensing unit on the roof is the be removed and the new VRF unit is to be installed in the same location.
- Existing refrigerant piping is to be removed, and the new refrigerant piping is to be routed down through the same chase to the Chase Bank.
- Supply and return grilles to be reused.
- Contractor to remove fan coil above ATM area that serves the vestibule.
