PART 3 - EXECUTION

3.1 **PROVISIONS**:

- A. Wages to workers, laborers and mechanics employed to work on this project, shall be paid in accordance with Section 220 of the Labor Law, and in accordance with the Prevailing Rate Schedules (**PRC #** found in the Project Manual) and proof of such payments will be required.
- B. This project is publicly funded. The Bidders must comply with the New York State Department of Labor Prevailing Wage Rate Schedule and conditions of employment. This Contract will be subject to a Project Labor Agreement (PLA) to be entered into between Rockland BOCES ("Owner") and the Rockland County Building and Construction Trades Council, AFL-CIO, and its affiliated Local Unions on behalf of themselves and their members. The finalized PLA will be added to the Bid Documents as an Addendum prior to the deadline for submission of bids. By submitting a Bid, the contractor will be required to agree that the PLA is binding on the Contractor and Subcontractors, will be required to execute a "Letter of Assent" prior to the award. Failure to execute the Letter of Assent will result in rejection of the Bidder.

The Bidder is advised to, prior to submission of its bid, review the PLA once finalized and added as an Addendum.

Rockland BOCES reserves the right to waive any informalities or irregularities in the Bids received, to the extent permitted by law, or to reject all Bids without explanation.

C. Each bid for the single prime Contract must be identified, in typed format, on the outside of a sealed manila envelope, with the name and address of the bidder and designated as bid for the Project titled above and appropriate Contract number and name titled above. The Rockland BOCES is not responsible for bids opened prior to the bid opening if bid contract number and opening date do not appear on the envelope. Bids opened prior to date and time indicated are invalid. The bidder assumes the risk of any delay in the mail, or in the handling of the mail by employees of the Rockland BOCES district, as well as improper hand delivery.

- D. Each proposal must be accompanied by a certified check in the sum of five percent (5%) of the amount of the bid, drawn upon a National or State Bank or Trust Company, payable to the order of the Rockland BOCES, or a bond from a surety licensed to practice business in the State of New York with sufficient sureties in a penal sum equal to five percent (5%) of the bid, conditioned that if this bid is accepted, successful bidder will enter into a contract for the same and that he will execute such further security as may be required for the performance of the contract.
- **E.** A separate Performance Bond, equal to one hundred percent (100%) of the contract amount will also be required of the successful bidders, and the bond shall be from a surety licensed to practice business in the State of New York, satisfactory to the School Board.
- **F.** A separate Payment Bond, equal to one hundred percent (100%) of the contract sum will also be required of the successful bidders, and the bond shall be from a surety licensed to practice business in the State of New York, satisfactory to the School Board.
- **G.** The bidders to whom the above referenced contracts may be awarded, shall within seven (7) days after the date of notification of the acceptance of their proposal, provide insurance and security as required by the above referenced contracts in a form acceptable by the Owner. In case of the bidders' failure to do so, or in case of the bidders' failure to give further security as herein prescribed, the bidders will be considered as having abandoned the same, and the certified check or other bid security accompanying the proposal shall be forfeited to the School District.
- H. Each bidder shall agree to hold his/her bid price for forty -five (45) days after the formal bid opening
