- Modifies Drawings: 00CP (Cover Page), HM-101, HM-102, HM-103, S-1, A100, A101, A102, A-103, A-110, A-113, AR201, A201, A300, A301, A725, M-001, MD-100, MD-101, MD-102, M-100, M-101, M-102, M-103, M-500, E-001, ED-100, E-101, E-102, E-500, SE-100, SE101, SE-102, P-001, P-101, and P-500.

### b. Additions:

- C-100, S-2, SE-000, SE-300, SE-301, SE303, SE-700, SE-701, SE-702A, SE-702B, SE-703A, SE-703B, SE-704, SE-705, SE-705A, SE-706, and PH-1
- 2. The following are clarifications to questions received for IFB-7084 "Roof Replacement and Select Interior Upgrades Part 3 of Roof Heat Plant & Window Replacement" at the Martin Luther King, Jr. Academy and the City's responses:
  - Question 1: Specify the contract responsible to furnish and install roof ladder per detail 33/A-113, new guard rail assembly per detail 36/A-113, chimney cap per detail 34/A-113, and roof hatch per details 27 and 28/A-113.
  - **Answer 1:** These items shall be provided under the GENERAL CONSTRUCTION ROOF CONTRACT 5.
  - Question 2. Verify the roof hatch detail 27/A-113 only applied to the main building.
  - Answer 2: New roof hatches are indicated on the Main Building as well as the Annex Building. Detail 28/A-113 applies to annex building only as noted.

- **Question 3:** Verify all skylights on roof of main building are replacing per detail 29/A-113 and specify the contract which is responsible to perform this work.
- Answer 3: All skylights shall be replaced; refer to the detail and specification. These items shall be provided under the GENERAL CONSTRUCTION ROOF CONTRACT 5.
- **Question 4:** Verify the detail 23/A-112 is applying on all 18 roof drains at main building and clarify if the existing roof drain body is to remain or replace. Also specify the contract which is responsible for this work.
- Answer 4: All roof drains on the main building shall be provided per detail 23/A-112 under the main building roof bid and be performed by the GENERAL CONSTRUCTION ROOF CONTRACT 5. This includes the note on the detail regarding replacing 2 feet of piping and insulation below the roof line. Refer to detail.
- Question 5: Specification section 012300 for Alternates indicates an Alternate EC1, however, there is no information on this alternate on the electrical drawings and very little information in the description provided. Additionally, there is no section on the bid form for this alternate. If this alternate should be in the project, please provide further information regarding what is involved in this alternate and please provide an updated bid form.
- Answer 5: Drawings ED-100 keyed note 9 and E-102 keyed note 13 provide scope of work for alternate EC1. Scope of work applies to the entirety of Kitchen Room 200 as indicated on the Drawings with reflected ceiling plans. If the alternate is accepted, all ceiling mounted fire alarm devices, cameras, wifi routers etc. are to be stored and reinstalled. Also, all lighting, switches, conductors, etc. in this room are to be removed. Provide new lighting, switches, conductors, etc. as indicated. See attached revised Drawings ED-100 and E-102. See revised drawings and Technical Specifications issued under this addendum.
- **Question 6:** There is a Type X1 fixture shown on E101 which appears to be an Exit sign, however, there is no Type X1 on the fixture schedule. Please provide the specified fixture manufacturer and model number.
- **Answer 6:** See attached revised drawing E-500 for specified exit signs.
- **Question 7:** Key Note 1 / E101 says "Provide conductors and conduit to connect new RTU panel to existing 100A breaker in existing panel PPMB1B." However, the riser diagram shows this differently, the new RTU Panel 3 is circuited from panel PP1, and it appears this circuit breaker is made spare through the removals process. Clarify the scope intent here.
- **Answer 7:** See revised Drawing E-101. Delete Note 1. RTU panel to be fed from new PP-1.
- **Question 8:** Alternate EC1, clarify Electrical Devices.
- Answer 8: Drawings ED-100 keyed note 9 and E-102 keyed note 13 provide scope of work for alternate EC1. Scope of work applies to the entirety of Kitchen Room 200 as indicated on the Drawings with reflected ceiling plans. If the alternate is accepted, all ceiling mounted fire alarm devices, cameras, wifi routers etc., are to be stored and reinstalled. Also, all lighting, switches, conductors, etc. in this room are to be removed. Provide new lighting, switches, conductors, etc. as indicated. See attached revised Drawings ED-100 and E-102. See revised drawings and Technical Specifications issued under this addendum.
- Question 9: Confirm conduits from main switch gear can be installed above existing ceiling I corridor. Will ceilings need to be replaced for this area work?
- Answer 9: Unless otherwise noted in the drawings and this Addendum, each contractor to carefully remove and store existing ceiling panels and grid system as required to access their work areas. Replace any damaged ceiling panels and or grid to match existing. Reinstall grid and panels upon completion of work. Refer to drawings.
- Question 10: Do we need to excavate and provide conduits for power and or data for the Hi-Tech Security work to get from the Main Building to the Annex?
- Answer 10: Use existing conduits connecting the Annex Building to the Main Building.
- Question 11: We need to provide notes and or drawing required for maintaining existing ventilation until the new RTUs are installed and commissioned. Existing equipment will need to stay in place until new RTUs and ductwork are installed and functioning. The intent is to complete all ductwork, ceilings and lights in the summer and RTUs get dropped when they arrive later in October/November? I recommend revising the drawing showing ductwork that ties in the old systems to the new. When the new RTUs are installed and commissioned the HVAC Contractor to performs as little as possible to remove and cap temp ductwork. Then they can demo existing HVAC systems.
- Answer 11: See attached new drawing PH-1 Partial Second Floor Plan Partial Phasing Plans. All contractors shall review and coordinate this drawing with their portions of the overall scope accordingly. This sheet offers a general phasing plan not a full scope of work for each contractor.
- Question 12: Confirm ceiling replacement scope work under HVAC new RTU2?

- Answer 12: This particular ceiling area is not set for replacement. Unless otherwise noted in the drawings and this Addendum each contractor to carefully remove and store existing ceiling panels and grid system as required to access their work areas. Replace any damaged ceiling panels and or grid to match existing. Reinstall grid and panels upon completion of work. Refer to Drawings
- Question 13: Revised specifications Section Summary of Work clarifying scope of work items are to be covered by which Trades.
- Answer 13: See Revised Specification Section 01 1000 Summary of Contracts
- **Question 14:** I need E&R to provide an estimate for the GC and Electrical Alternates.
- Answer 14: Budgets for Base Bid and Alternate will be disclosed at date of Bid Opening.
- Question 15: Specification section 012300 for Alternates indicates an Alternate EC1, however, there is no section on the bid form for this alternate.
- Answer 15: See attached revised Specification Section 01 2300 Alternates and revised Bid Forms BSP-1 and BSP-3.
- Question 16: Revised specifications Section Summary of Work clarifying scope of work items are to be covered by which Trades.
- **Answer 16:** See Revised Specification Section 01 1000 Summary of Contracts.
- Question 17: Specification section 012300 for Alternates indicates an Alternate EC1, however, there is no section on the bid form for this alternate.
- Answer 17: See attached revised Specification Section 01 2300 Alternates and revised General Construction Contract 1 and Electrical Contract 2 Bid Schedule of Prices.
- Question 18: The plans refer to the annex building but the spec book refers to the 'modular' building. Can you confirm this is the same building?
- Answer 18: The Annex Building, Annex/Modular and Modular Building are same Building.
- Question 19: If so, the bid form lists a column for work performed in the modular building but the contract summary says no work in the modular building. Please clarify?
- Answer 19: Specification Section 01 1000 Summary of Contracts and revised Bid Forms BSP-1 and BSP-3 issued under this Addendum 2.
- Question 20: Plan A300 calls for AC unit to be installed in a metal panel. Are these panels new or existing? Please clarify.
- Answer 20: The panels are being installed under a separate GENERAL CONSTRUCTION WINDOW Contract under Bid IFB-7035A.

  Under this Bid IFB-7084 The GENERAL CONSTRUCTION BUILDING CONTRACT 1 AND ELECTRICAL –

  CONTRACT 3 contractors will be required to coordinate scheduling their work related to the Window AC Units with the GENERAL CONSTRUCTION WINDOW Contractor. The GENERAL CONSTRUCTION WINDOW Contract under Bid IFB-7035A is anticipated to start as soon as materials arrive on site in September 2024 and be completed at or around end of November 2024. The lowest responsive bidder for Bid IFB-7035A is PB Contracting Corp, Kashif Naseem at (631) 627-9024.
- Question 21: Please clarify who is furnishing and installing Window AC Units, associated sleeves and sleeve support frames?
- Answer 21: The HVAC CONTRACT 3 contractor furnishes Window AC Units & Sleeves. The GENERAL CONSTRUCTION BUILDING CONTRACT 1 contractor shall furnish and install the Window AC Unit sleeve support frames and cut openings into the panels for the new windows being installed under Bid IFB-7035A. The GENERAL CONSTRUCTION BUILDING CONTRACT 1 contractor shall install the sleeves into the support frames and install Window AC Unit and seal weather tight. The GENERAL CONSTRUCTION BUILDING CONTRACT 1 contractor shall maintain the window warranty issued by GENERAL CONSTRUCTION WINDOW Contract under Bid IFB-7035A. The lowest responsive bidder for Bid IFB-7035A is PB Contracting Corp, Kashif Naseem at (631) 627-9024.
- Question 22: If so, the bid form lists a column for work performed in the modular building but the contract summary says no work in the modular building. Please clarify?
- Answer 22: The GC has no work in the modular/annex building. GC shall submit bid(s) for the main building only. Delete notes WS3, WS6 and WS23 from annex building. All other work on the outside of the Annex Building is by GC under their main building bid. There is only roofing and electrical (security) work at the annex building.
- Question 23: If so, the bid form lists a column for work performed in the modular building but the contract summary says no work in the modular building. Please clarify

- Answer 23: See revised Technical Specifications Section 01 1000 Summary of Contracts.
   Question 24: Refer to specification manual, Pg. 65, location and quantities are provided for affected ACM. However there are no work disturbances at these locations.
- Answer 24: The Asbestos Survey was originally done for a broader scope of work. The ACM included in this project is shown on the HM series Drawings.
- Question 25: Refer to specification, Pg. 140 summary of PCB test result summary table is provided. However, there is no disturbance of work at these locations.
- Answer 25: The PCB testing report was originally done for a broader scope of work. The PCB work included in this project is shown on the HM series Drawings.
